Dataset Title:

NOAA RESTORE Science Program: Living shoreline site suitability model transfer for selected water bodies within the Gulf of Mexico: Best Management Practice for Lake Pontchartrain, Louisiana.

Description:

Best Management Practice for living shoreline armoring in Lake Pontchartrain, Louisiana, based on Shoreline Management Model (SMM) V5.1 model created by Virginia Institute of Marine Science, Center for Coastal Resources Management, digital format as shapefile.

Purpose:

This dataset was created to help determine alternate shoreline best management practices for Lake Pontchartrain, Louisiana.

Shoreline Management Model (SMM) Version 5.1 for preferred shoreline best management practices for Lake Pontchartrain, Louisiana, NOAA Restore Science Program and Troy University, and VIMS CCRM.

The data in this accession were funded by the NOAA National Centers for Coastal Ocean Science (NCCOS) RESTORE Science Program under award NA17NOS4510100 to Troy University.

Methods:

Troy University digitized shoreline around Lake Pontchartrain based on satellite imagery from ArcGIS Imagery Base Map. Troy University used DEM data obtained from Lake Pontchartrain Basin Foundation to delineate bank height. Troy University used bathymetry data obtained from Louisiana Coastal Protection and Restoration Authority to delineate water depth. Troy University used Land Use/Land Cover obtained from USGS to delineate Riparian LU. Troy University used satellite imagery from ArcGIS Imagery Base Map to aid in delineating canal, roads, Beach, Exposure, Structure, Sand Spit, Permanent Structures, and forested shoreline. Troy University attributed these fields for the input to run the model version 5.1.
