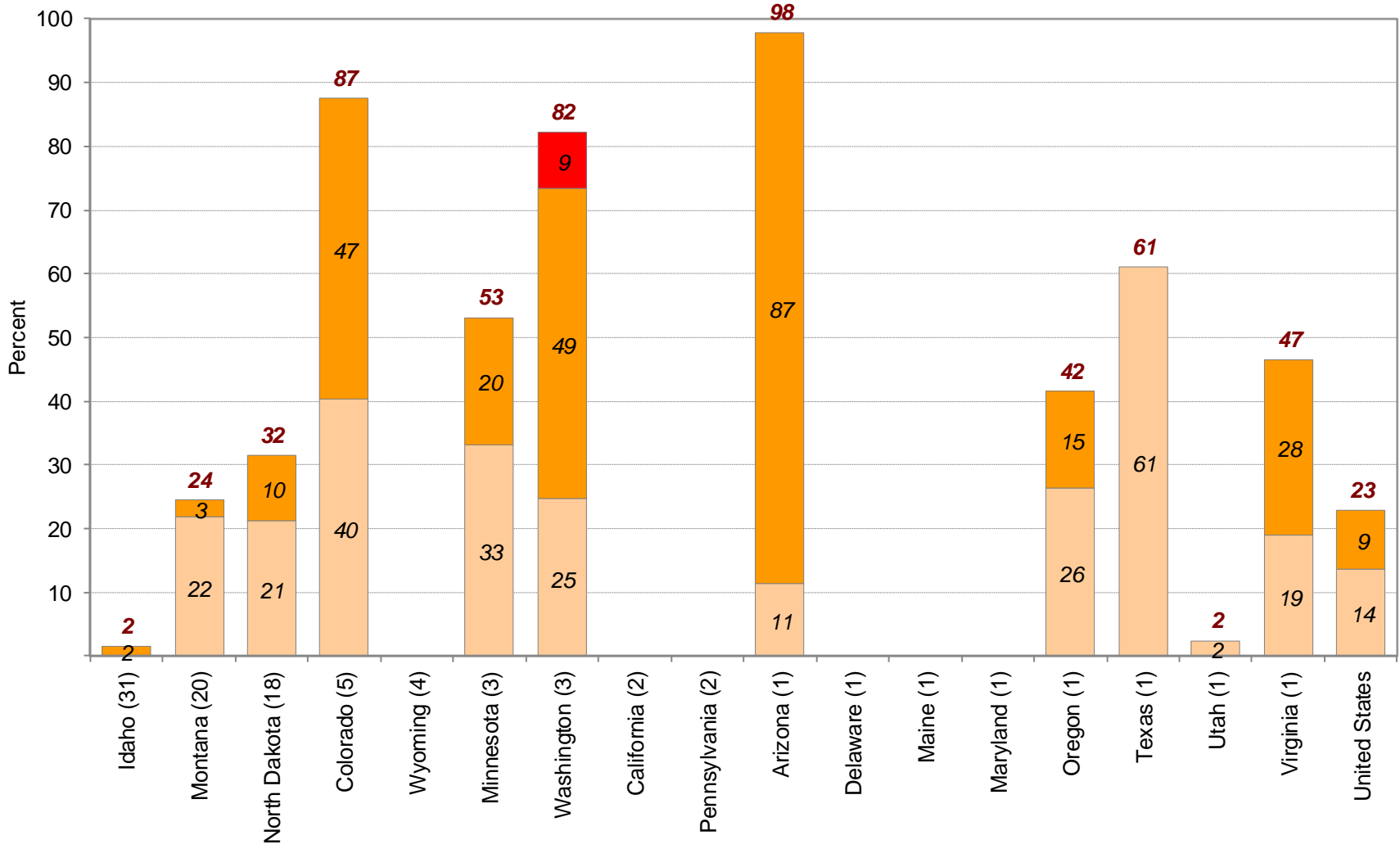

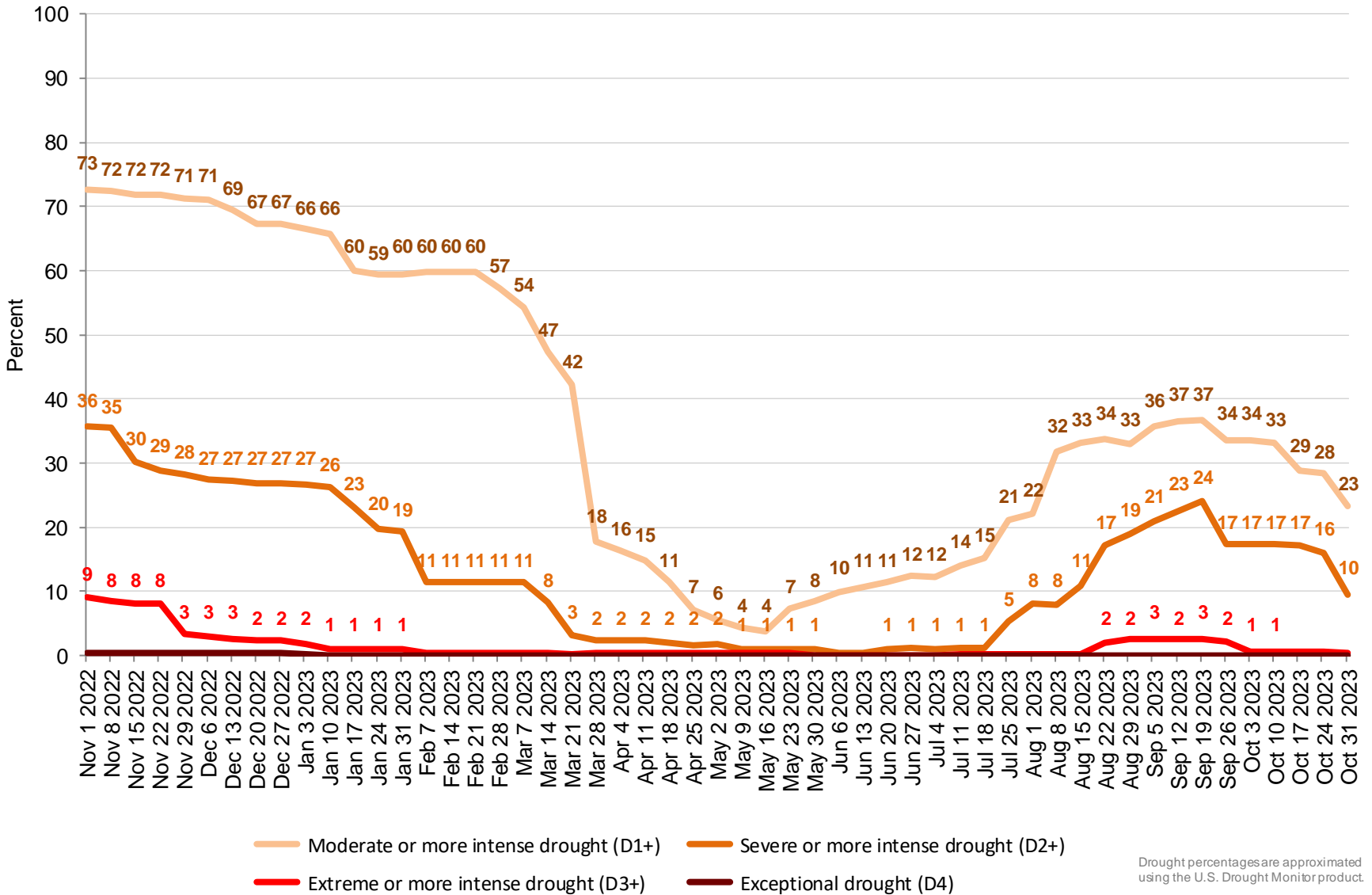
Percent of Barley Located in Drought October 31, 2023

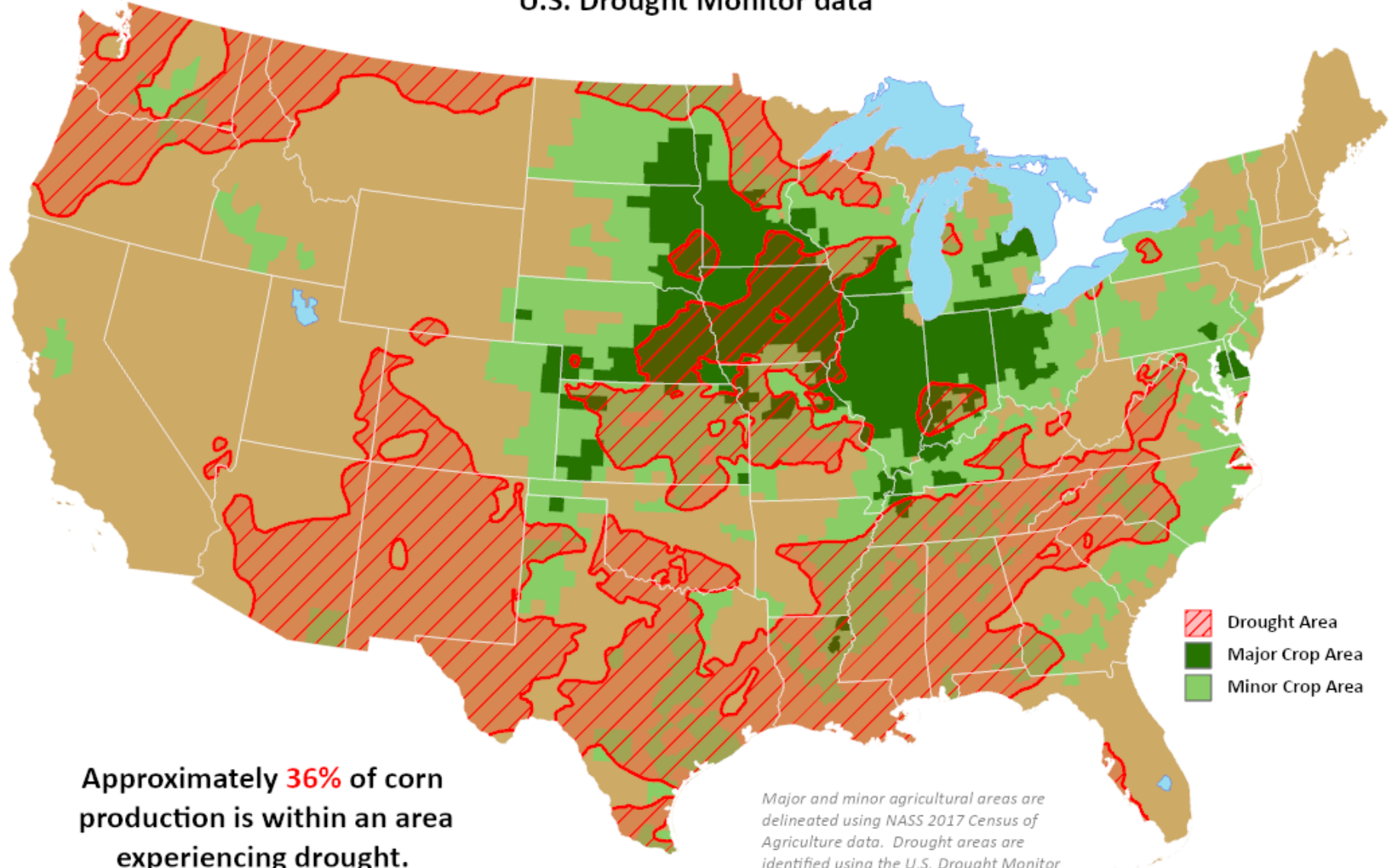
Percent of United States Barley Located in Drought

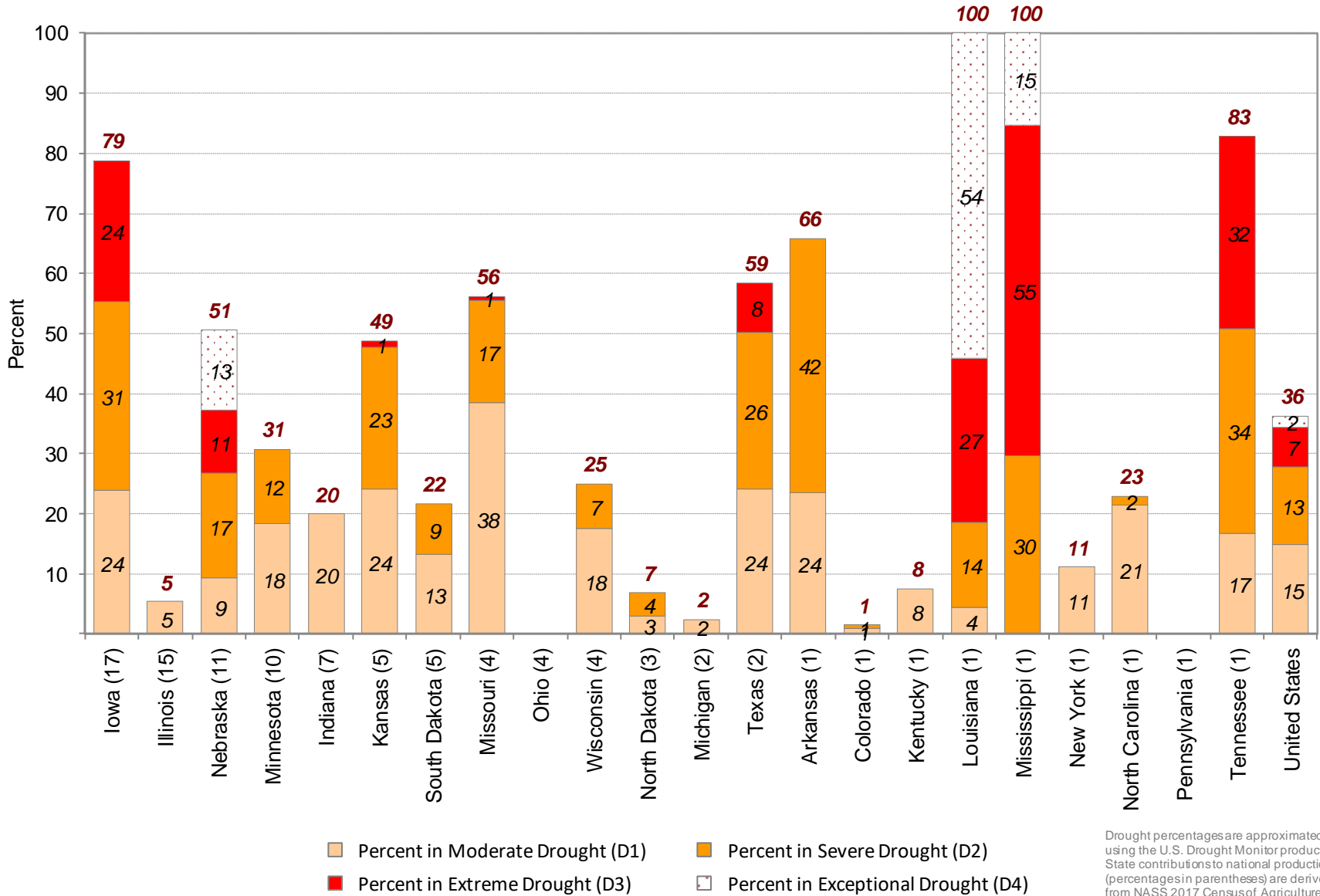

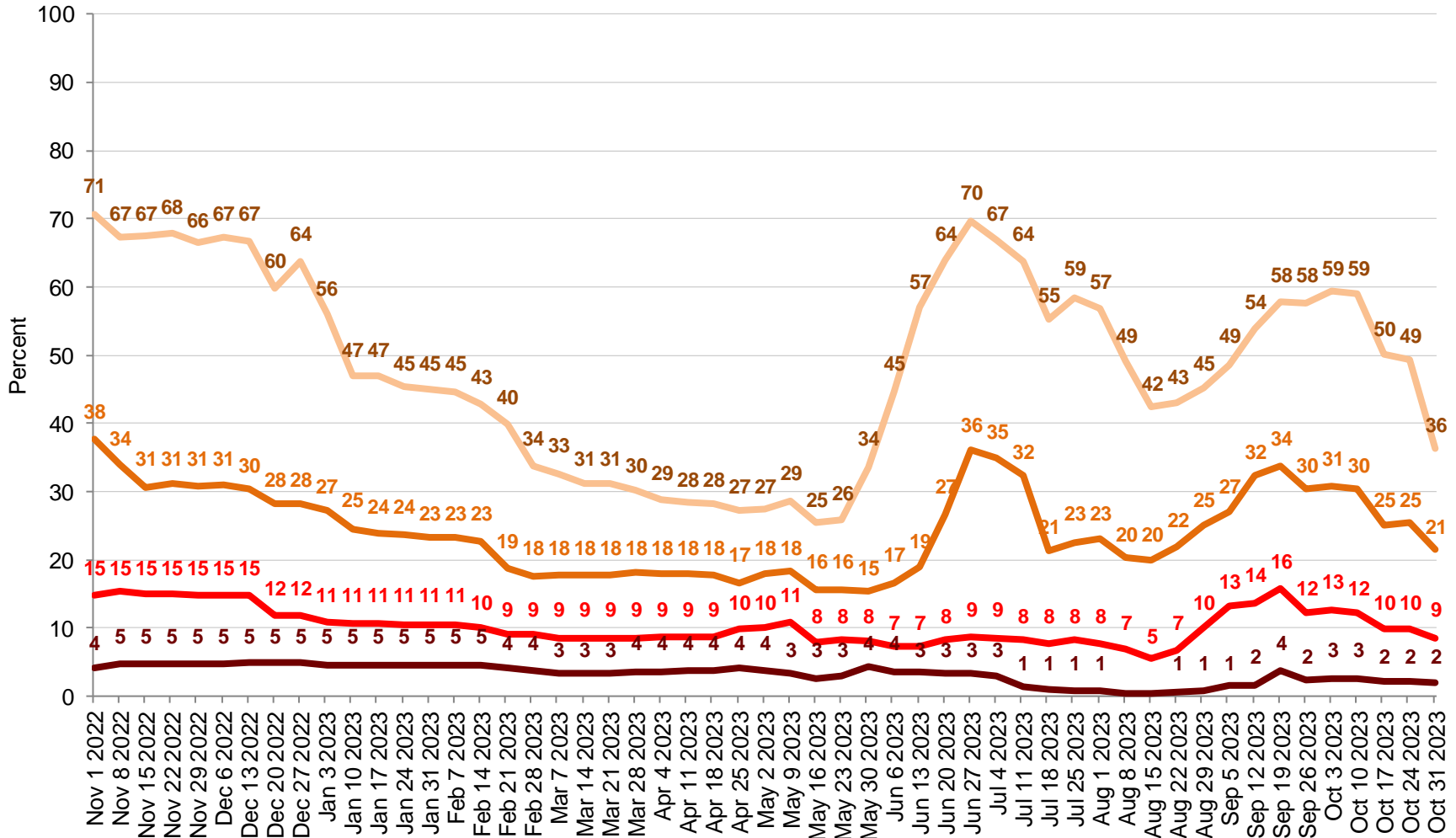

Percent of United States Corn Located in Drought



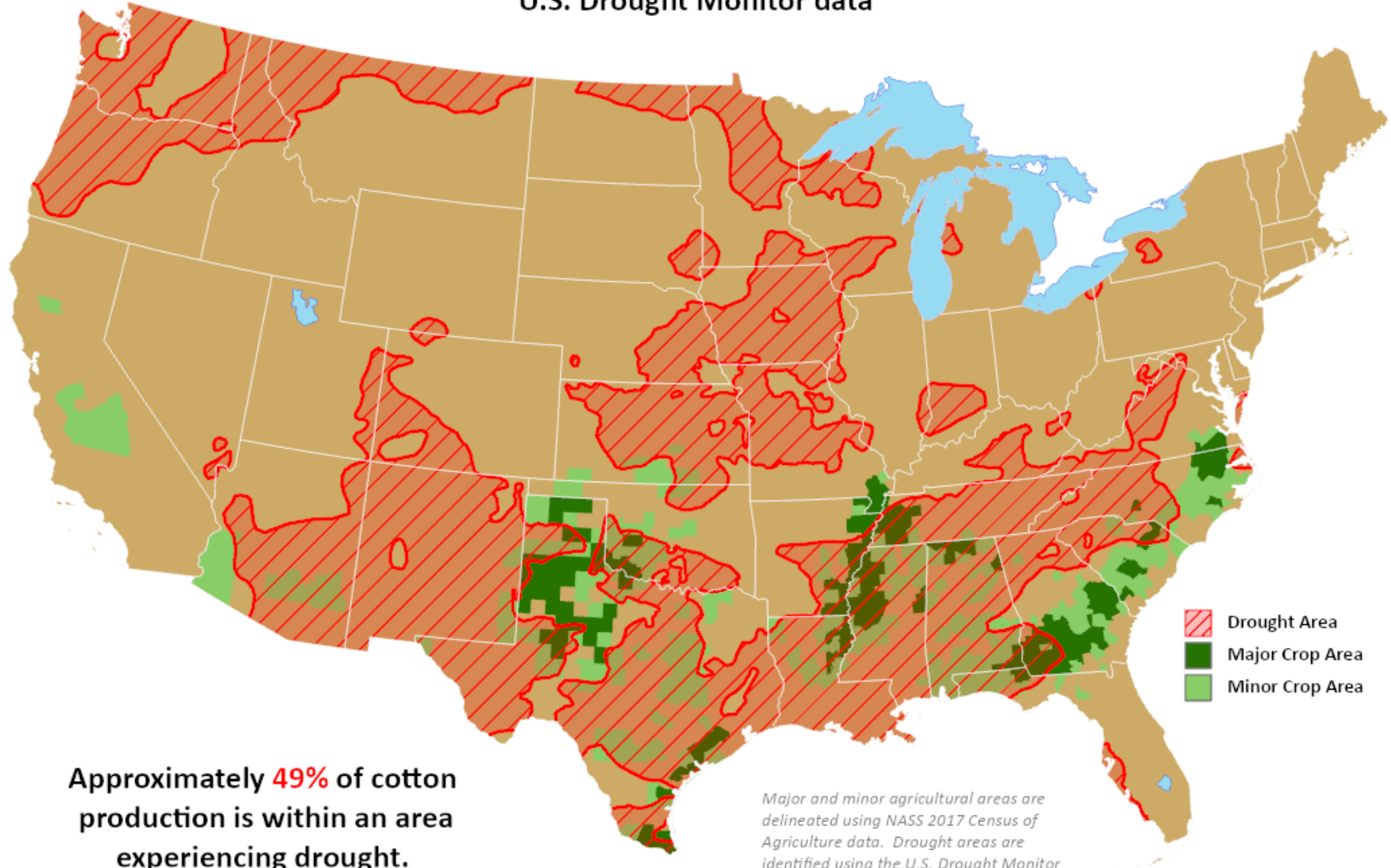

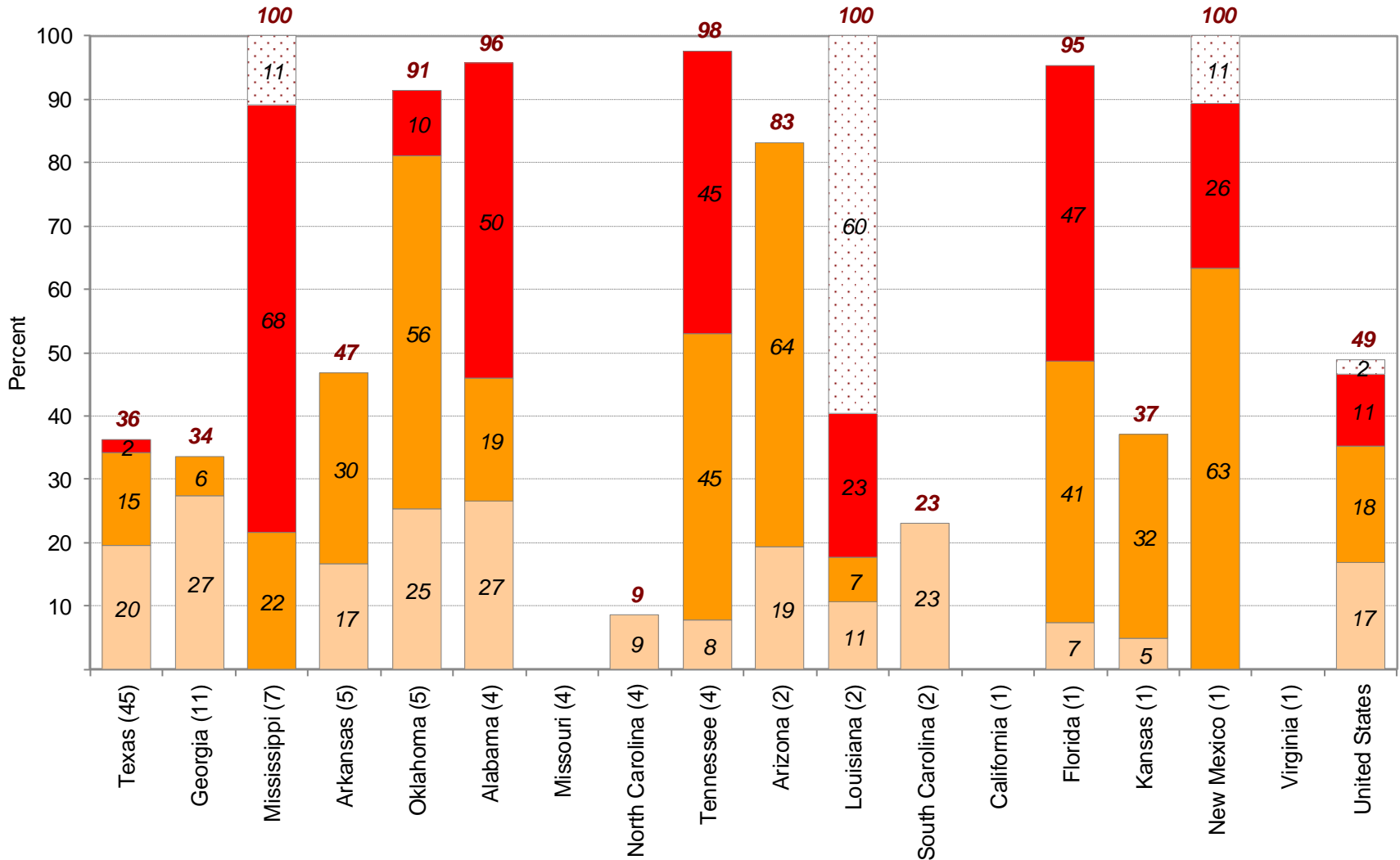

Percent of Cotton Located in Drought

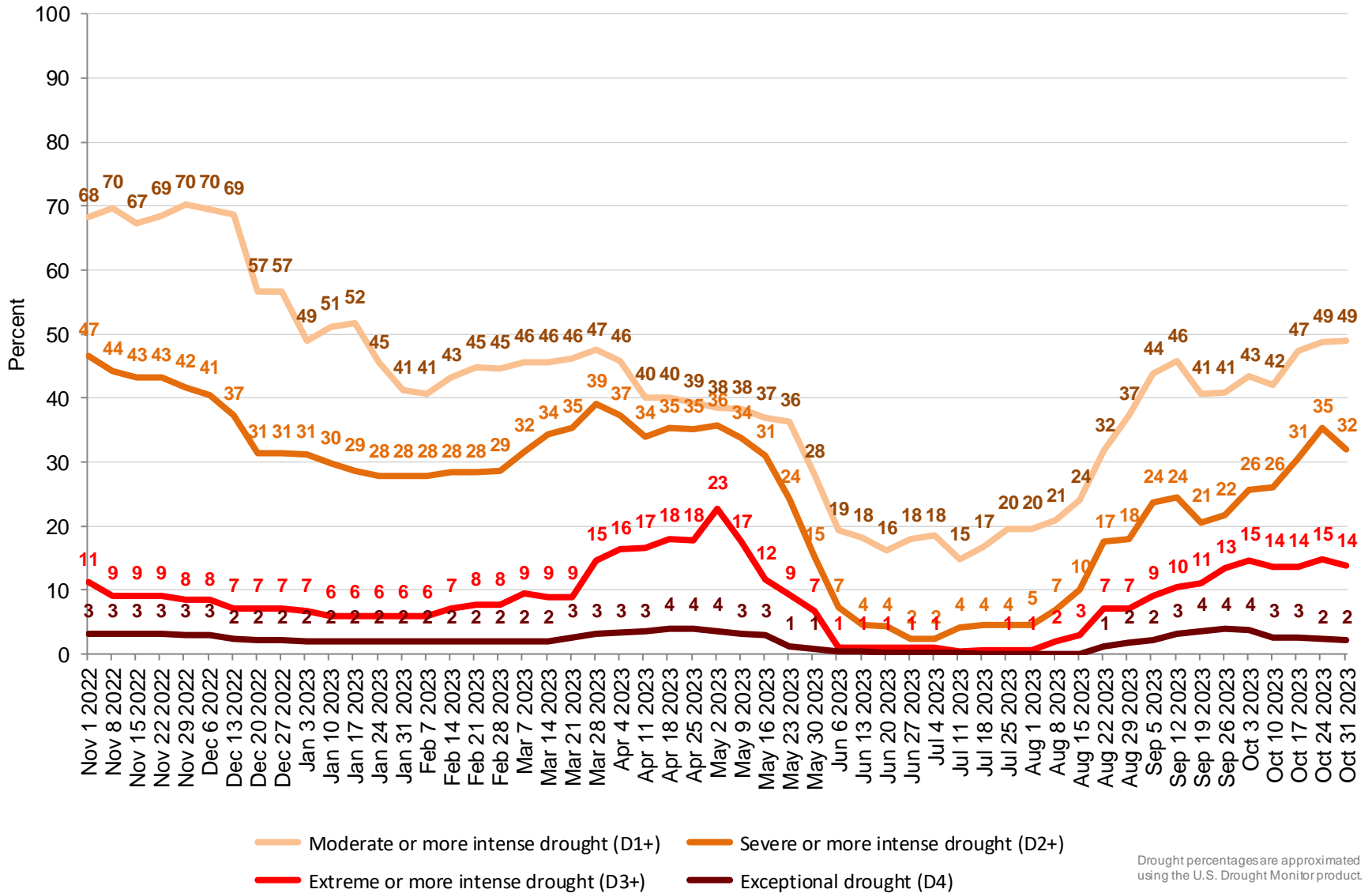

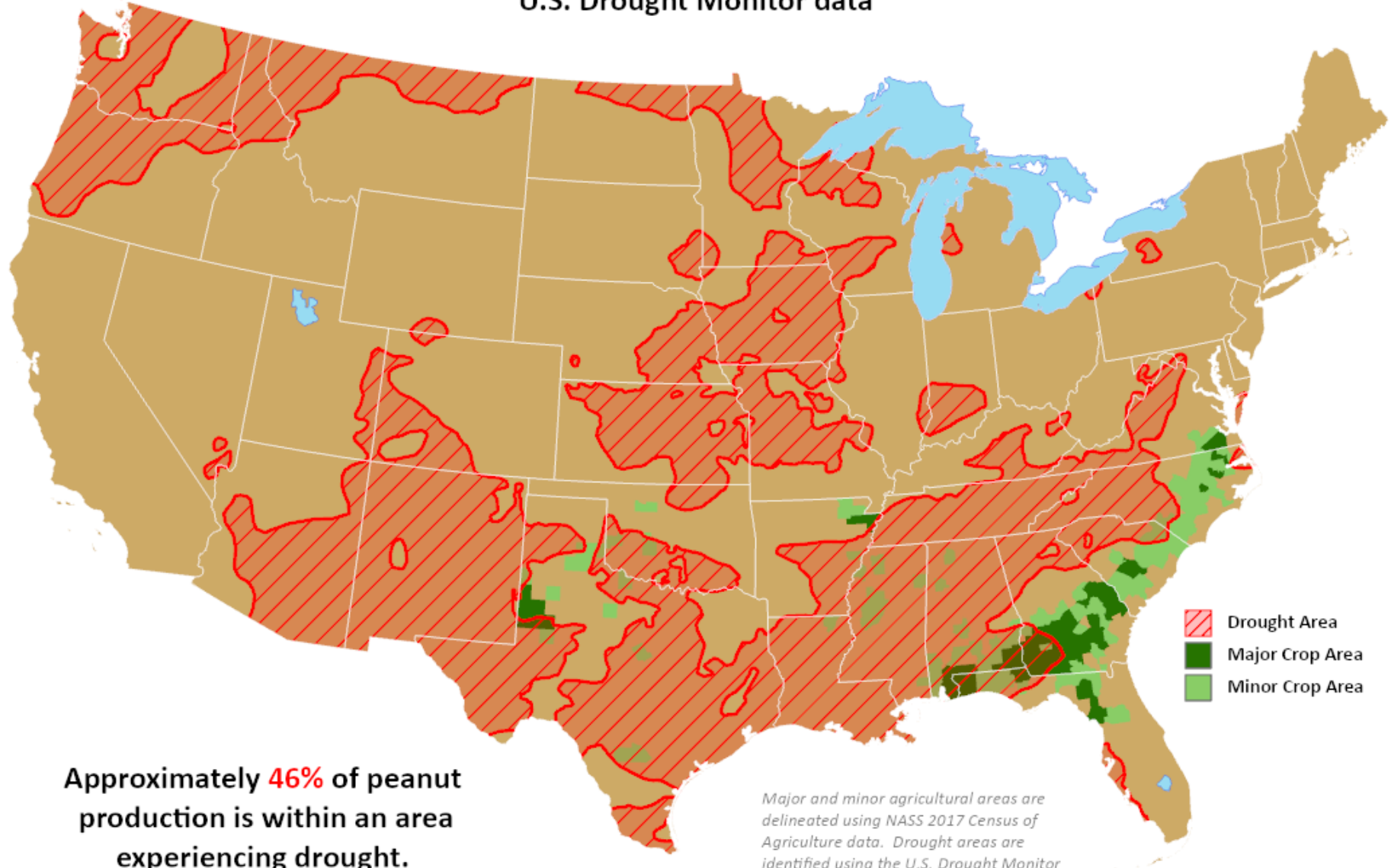
Percent of United States Cotton Located in Drought

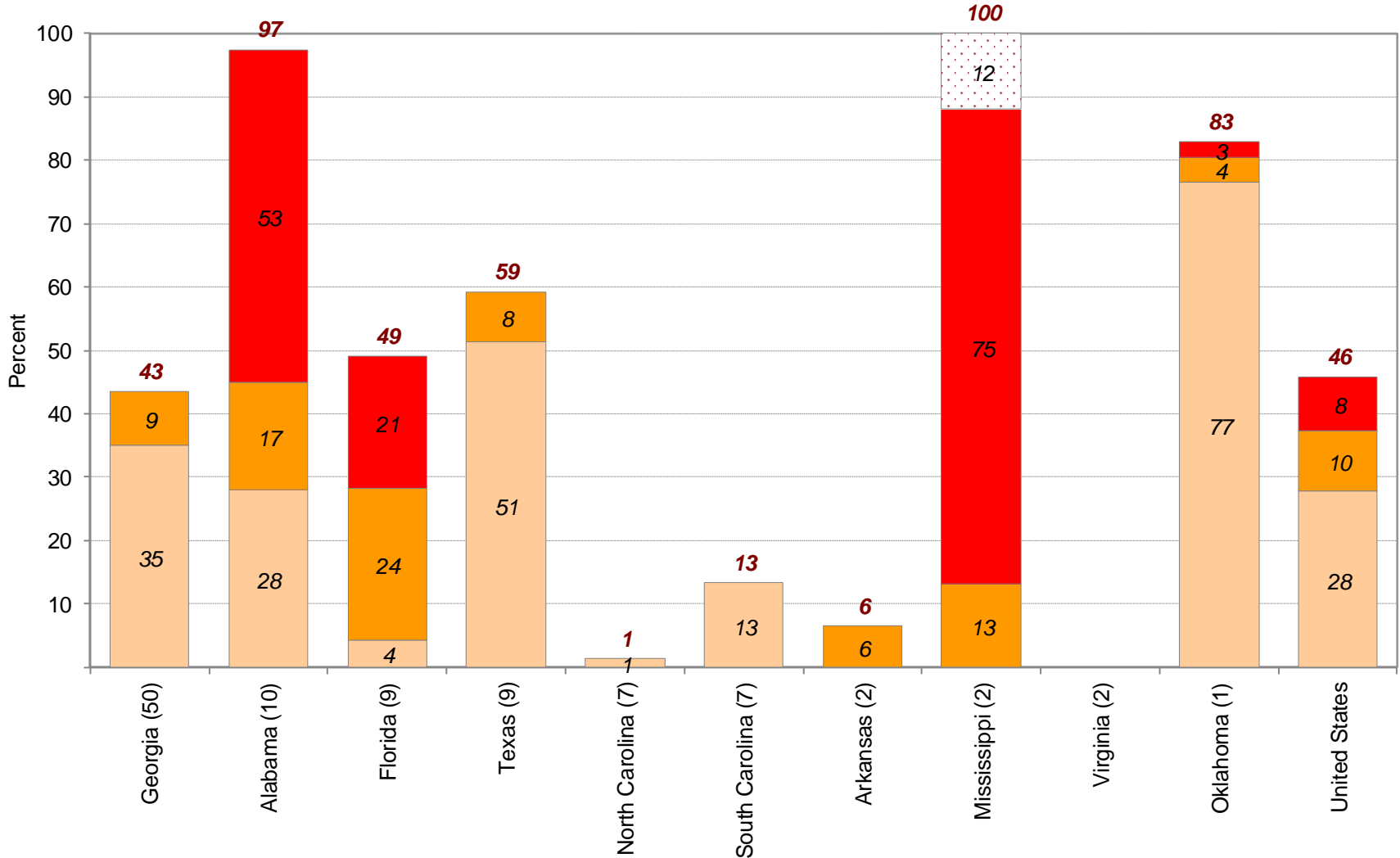

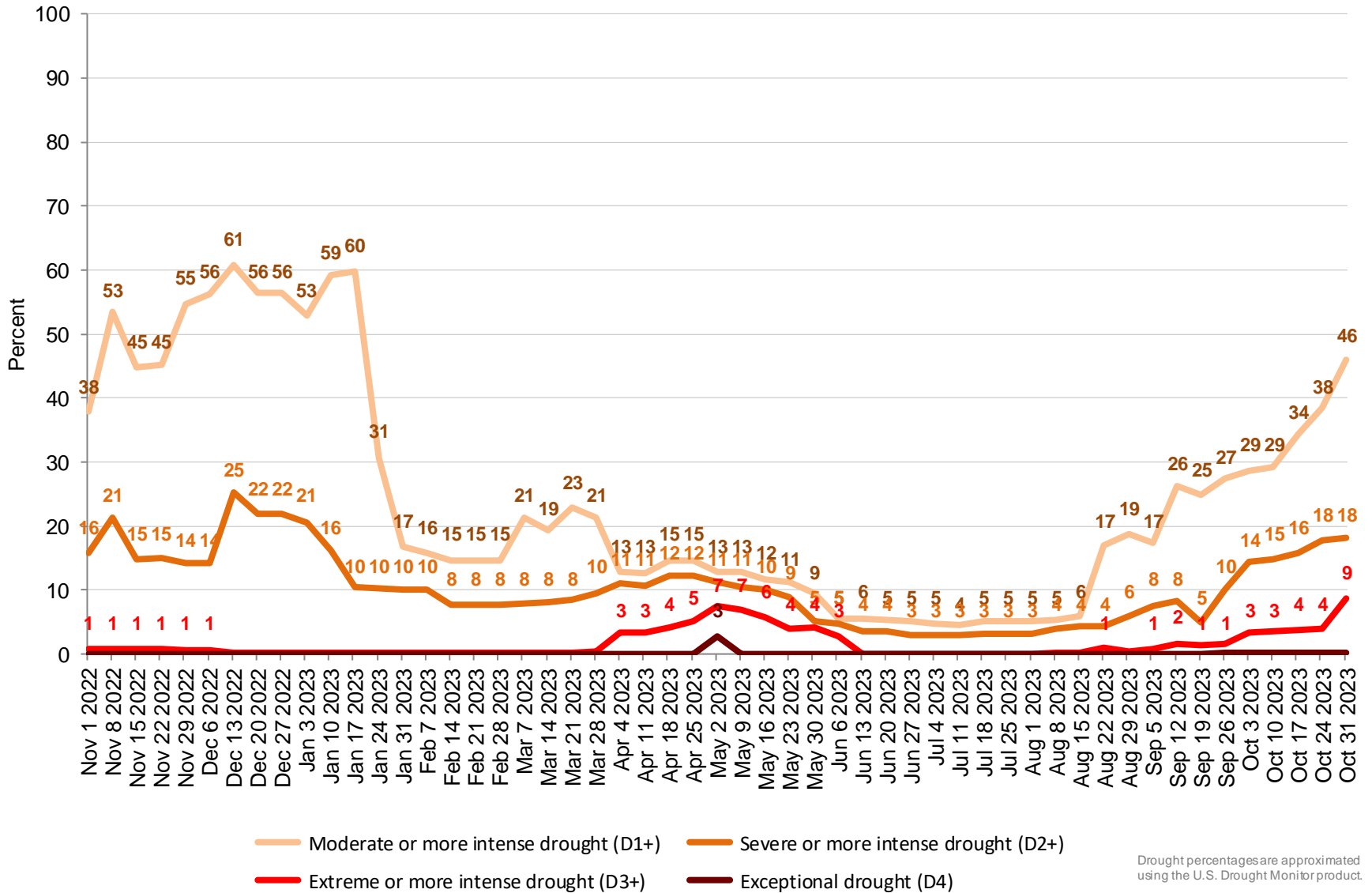
Percent of Peanuts Located in Drought October 31, 2023

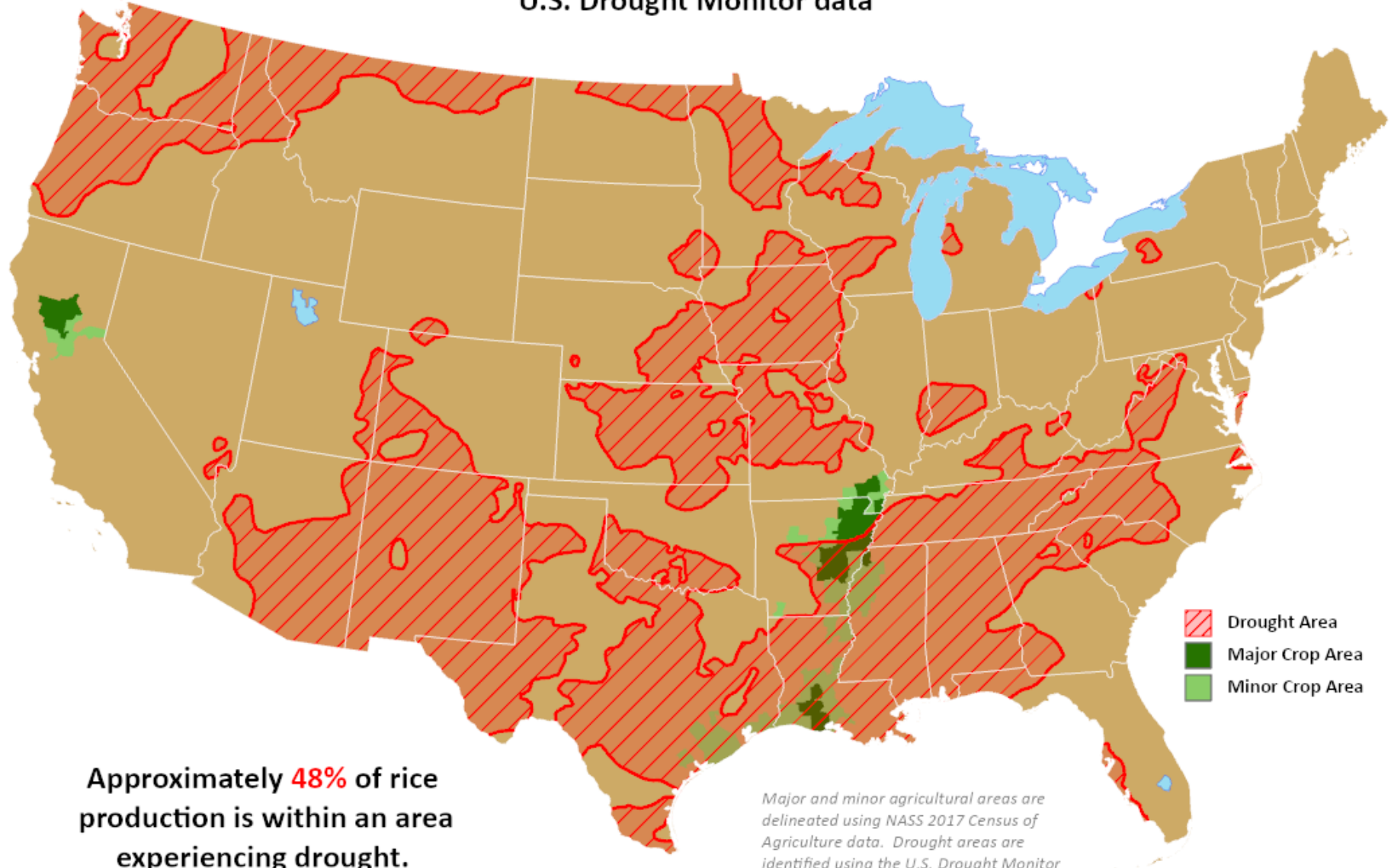
Percent of United States Peanuts Located in Drought

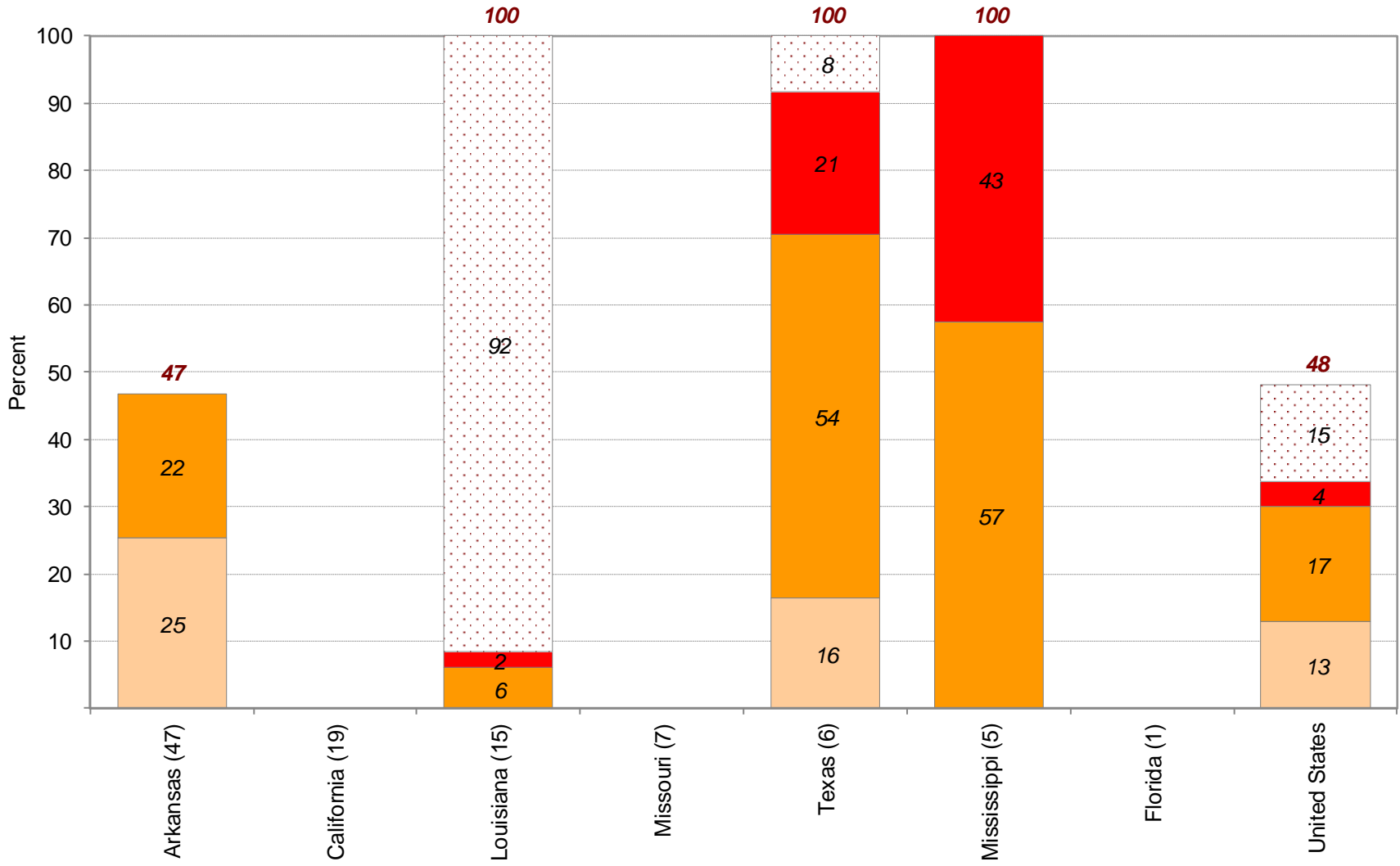

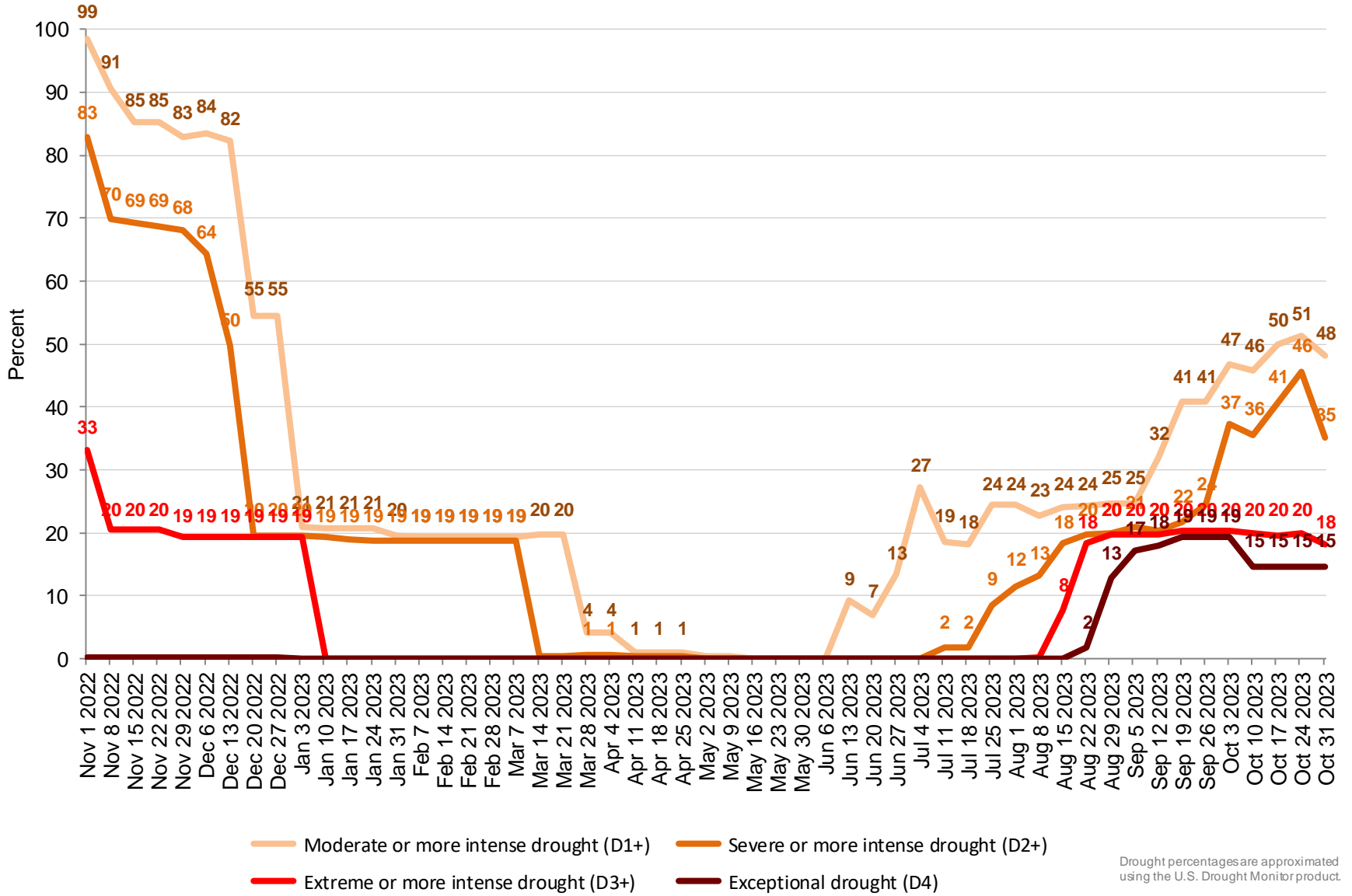
Percent of Rice Located in Drought October 31, 2023

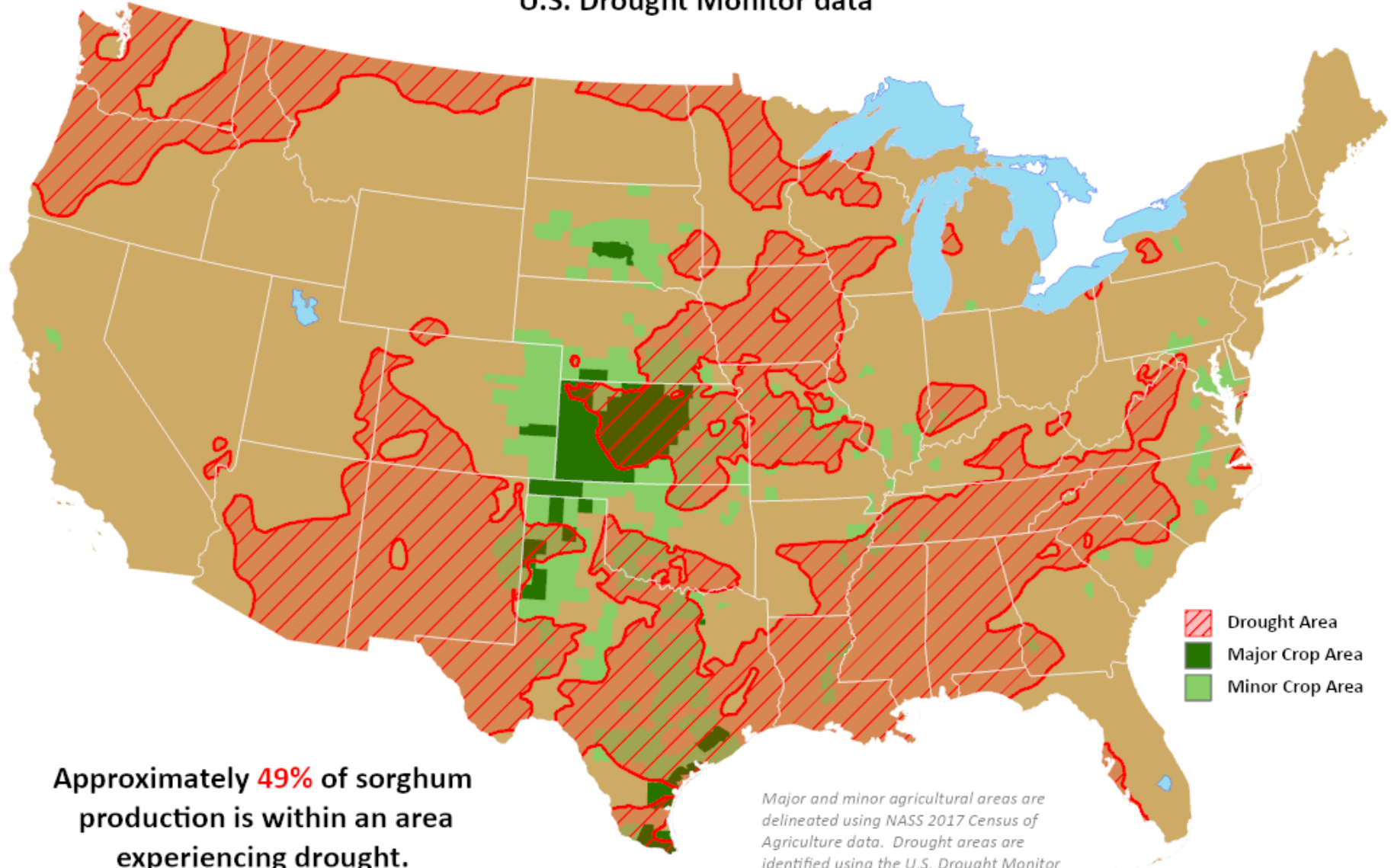
Percent of United States Rice Located in Drought

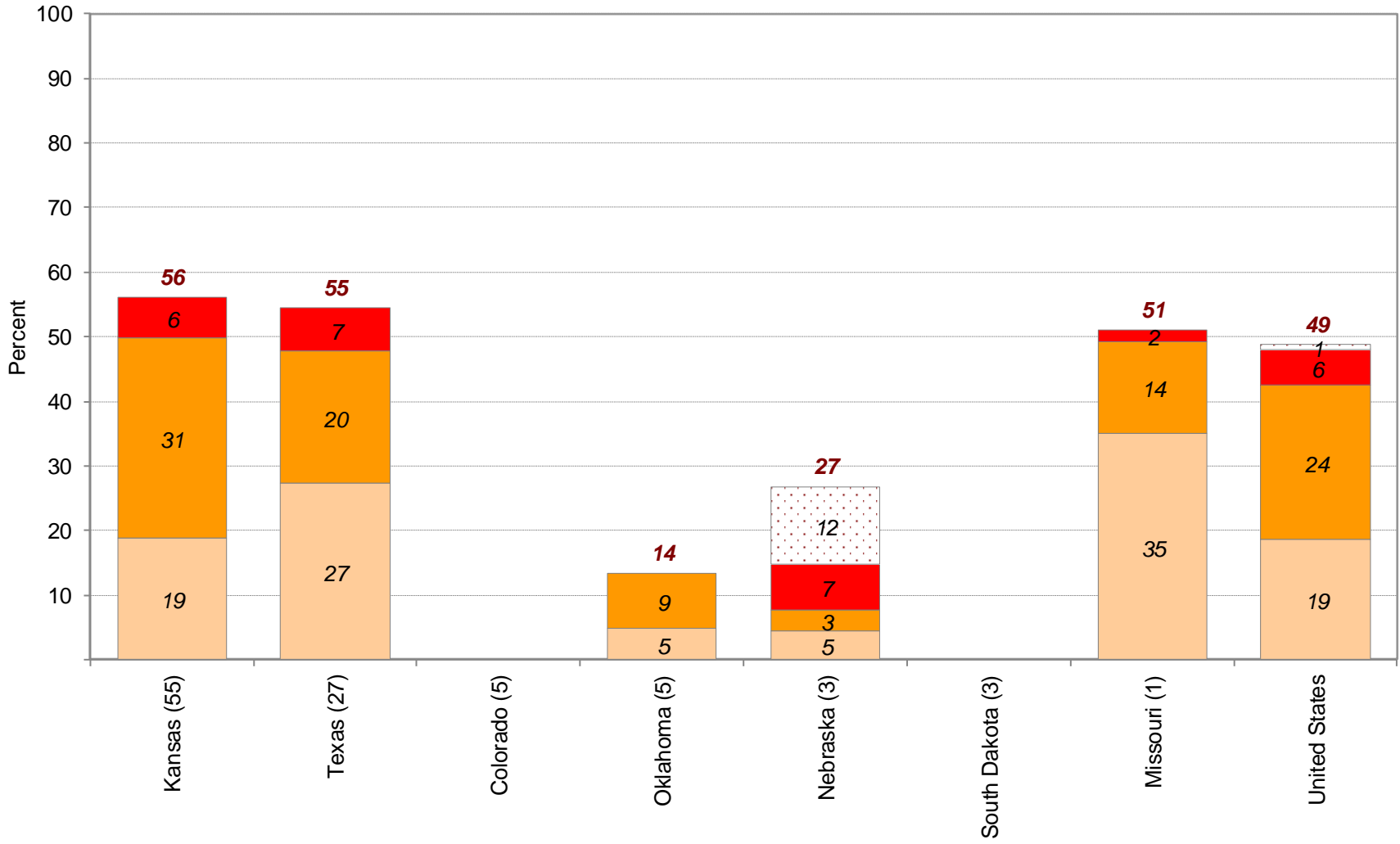

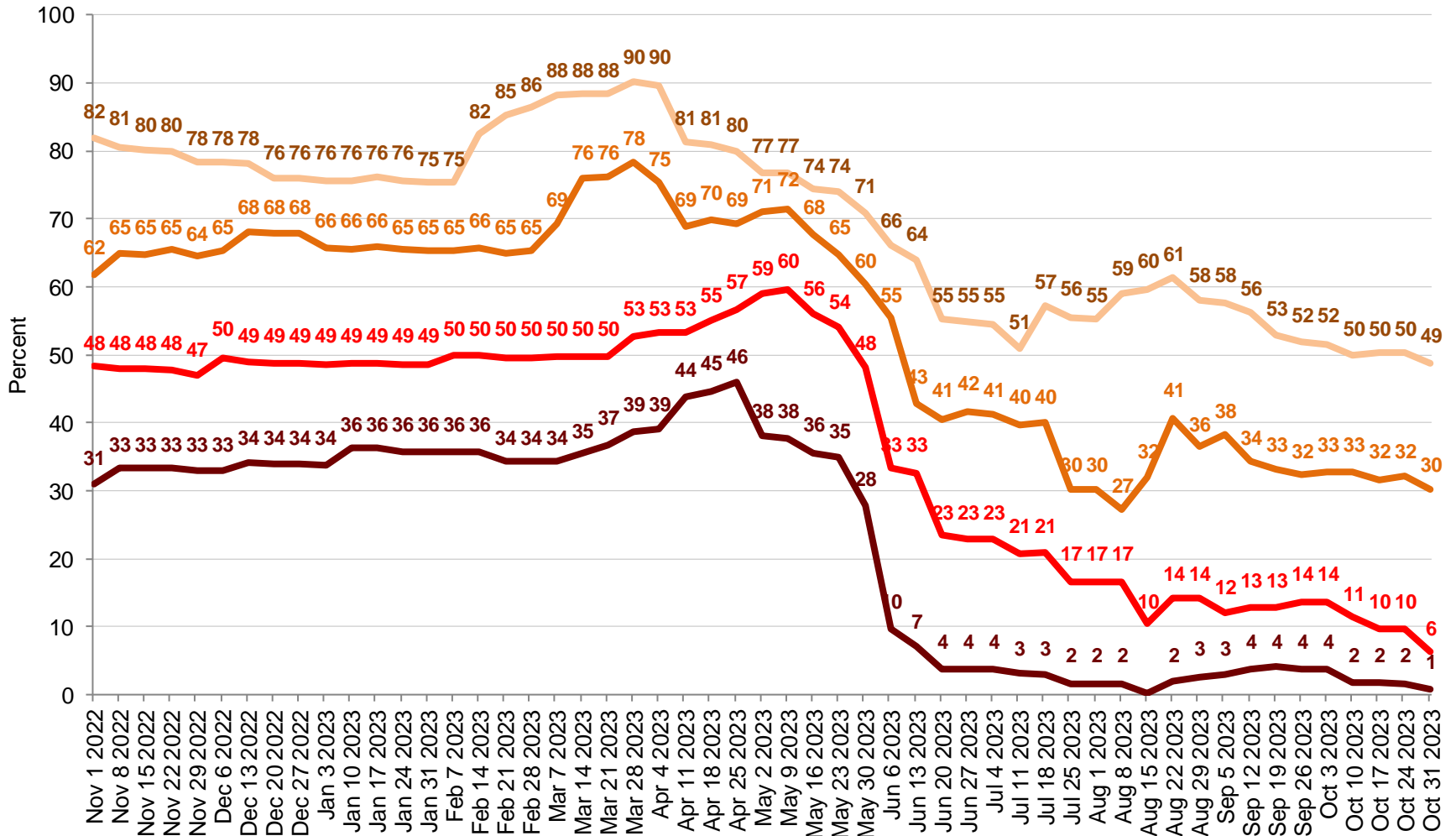
Percent of Sorghum Located in Drought October 31, 2023

Percent of United States Sorghum Located in Drought

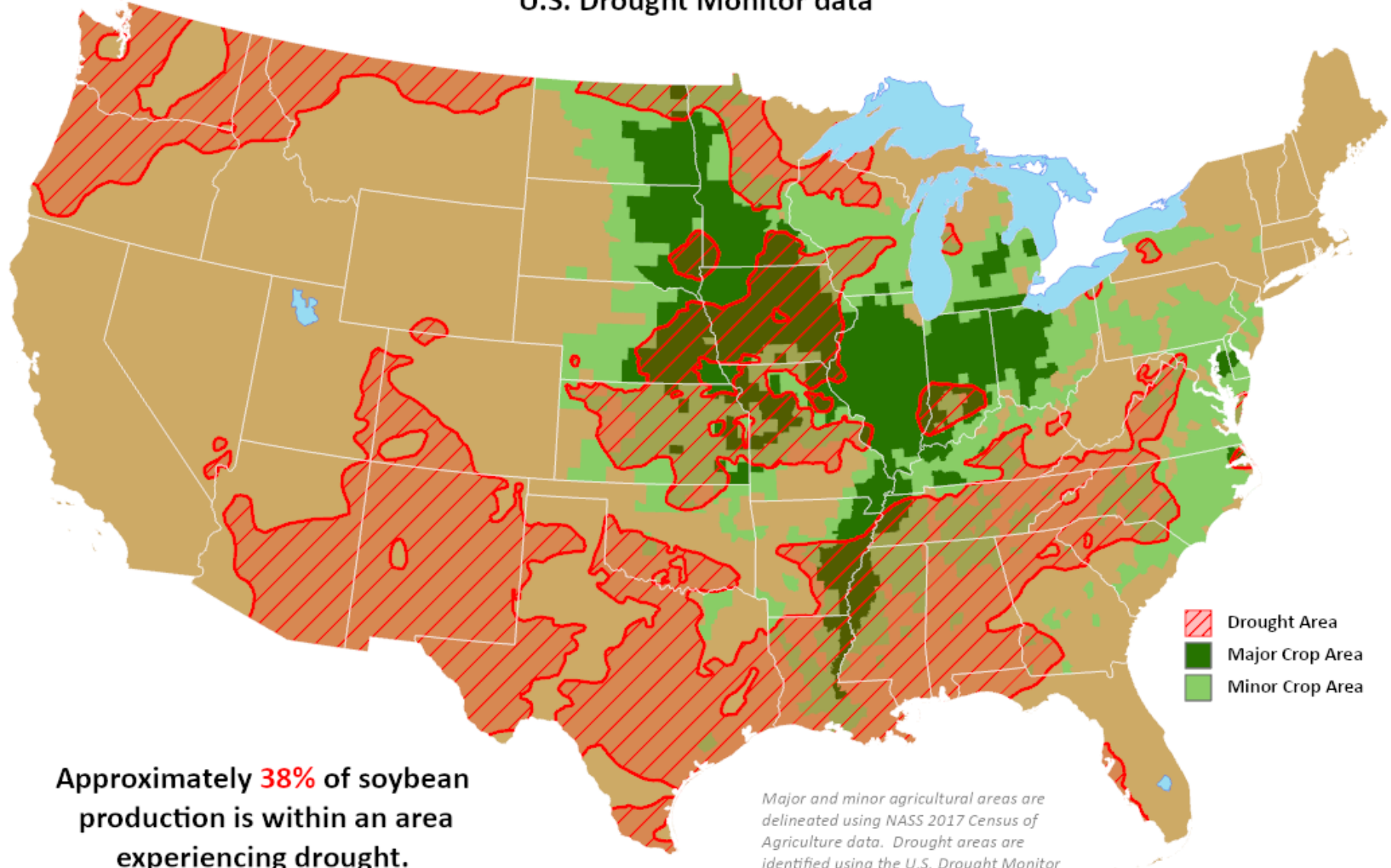

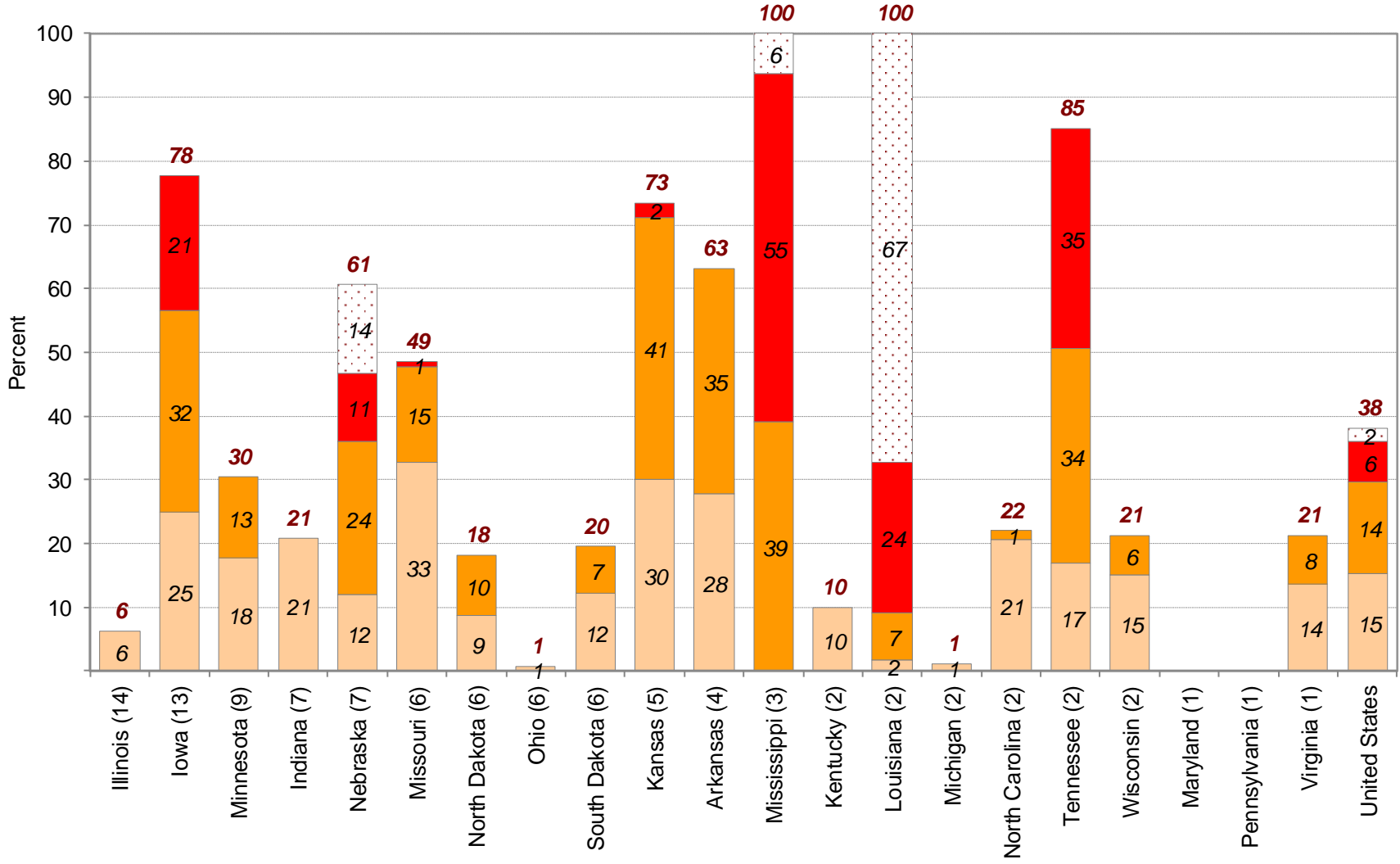

Percent of Soybeans Located in Drought

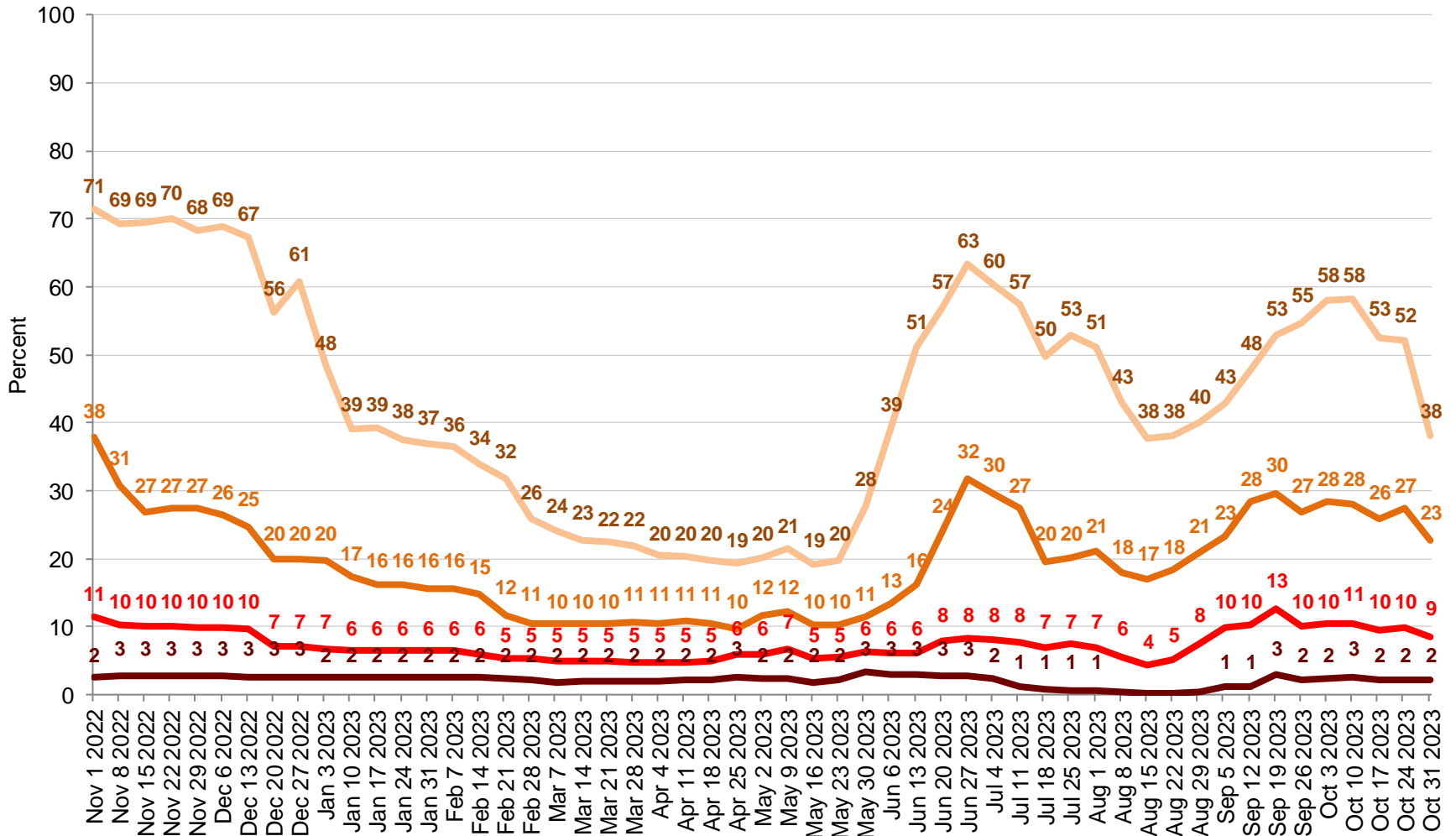

Percent of United States Soybeans Located in Drought



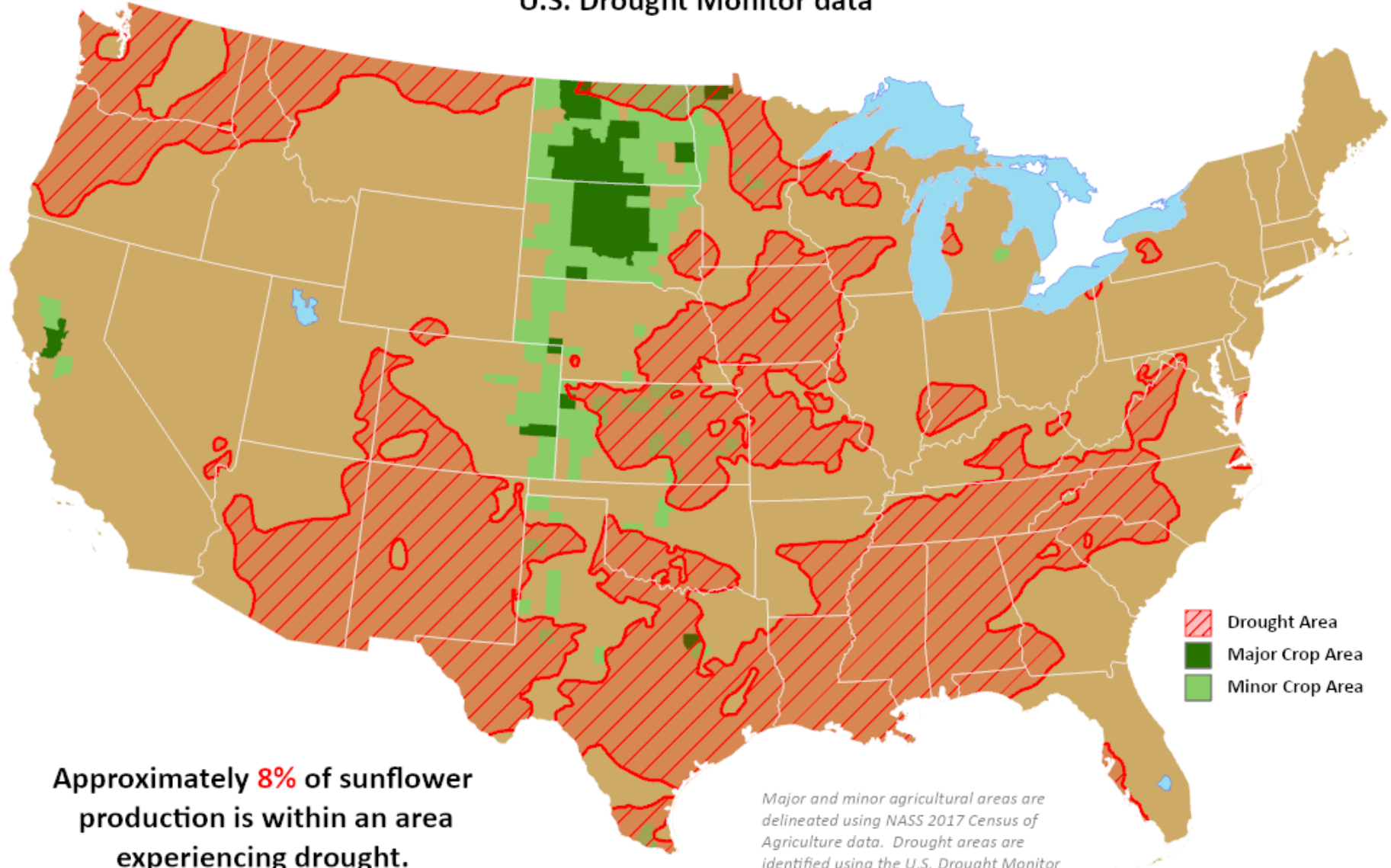

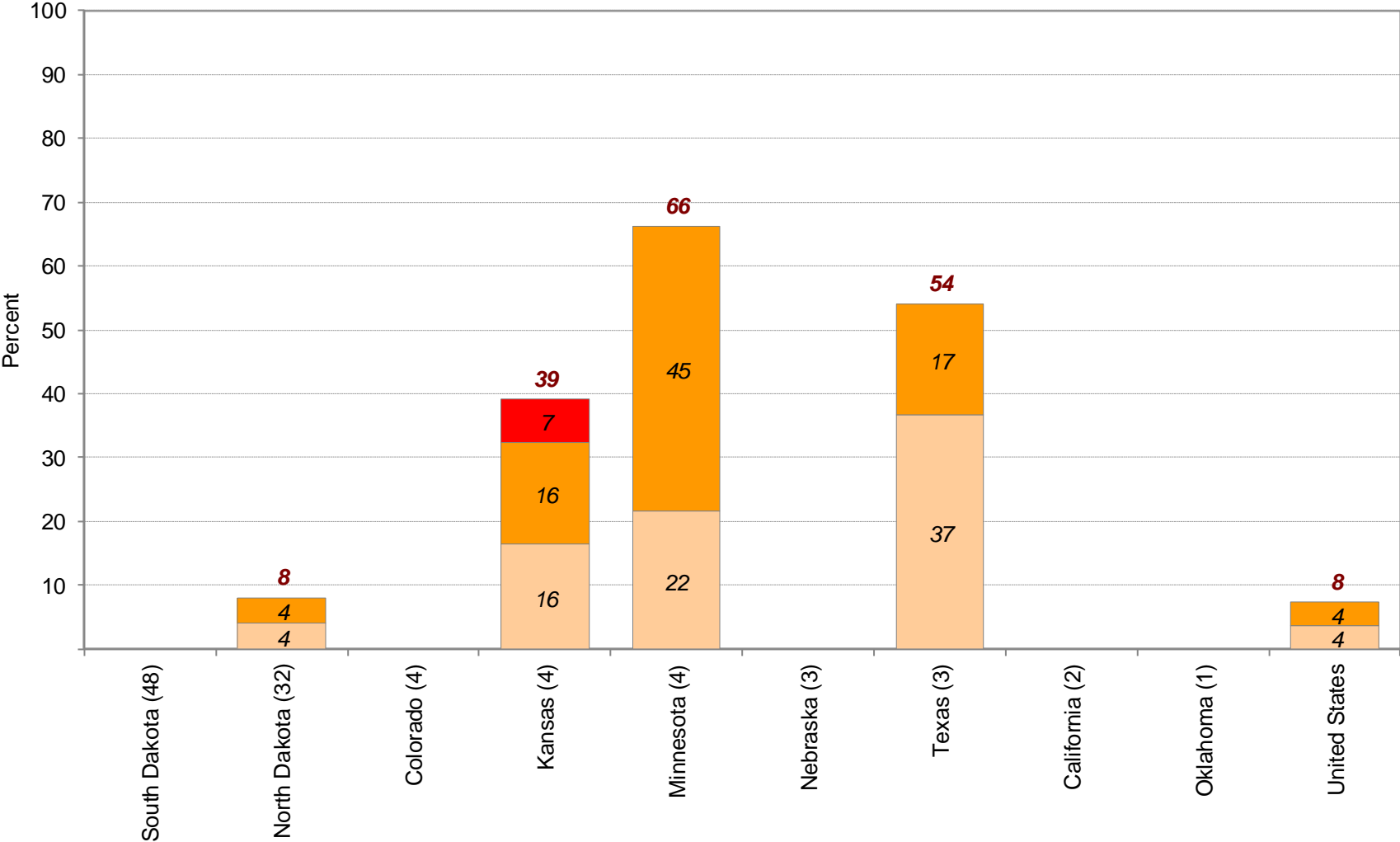

Percent of Sunflowers Located in Drought

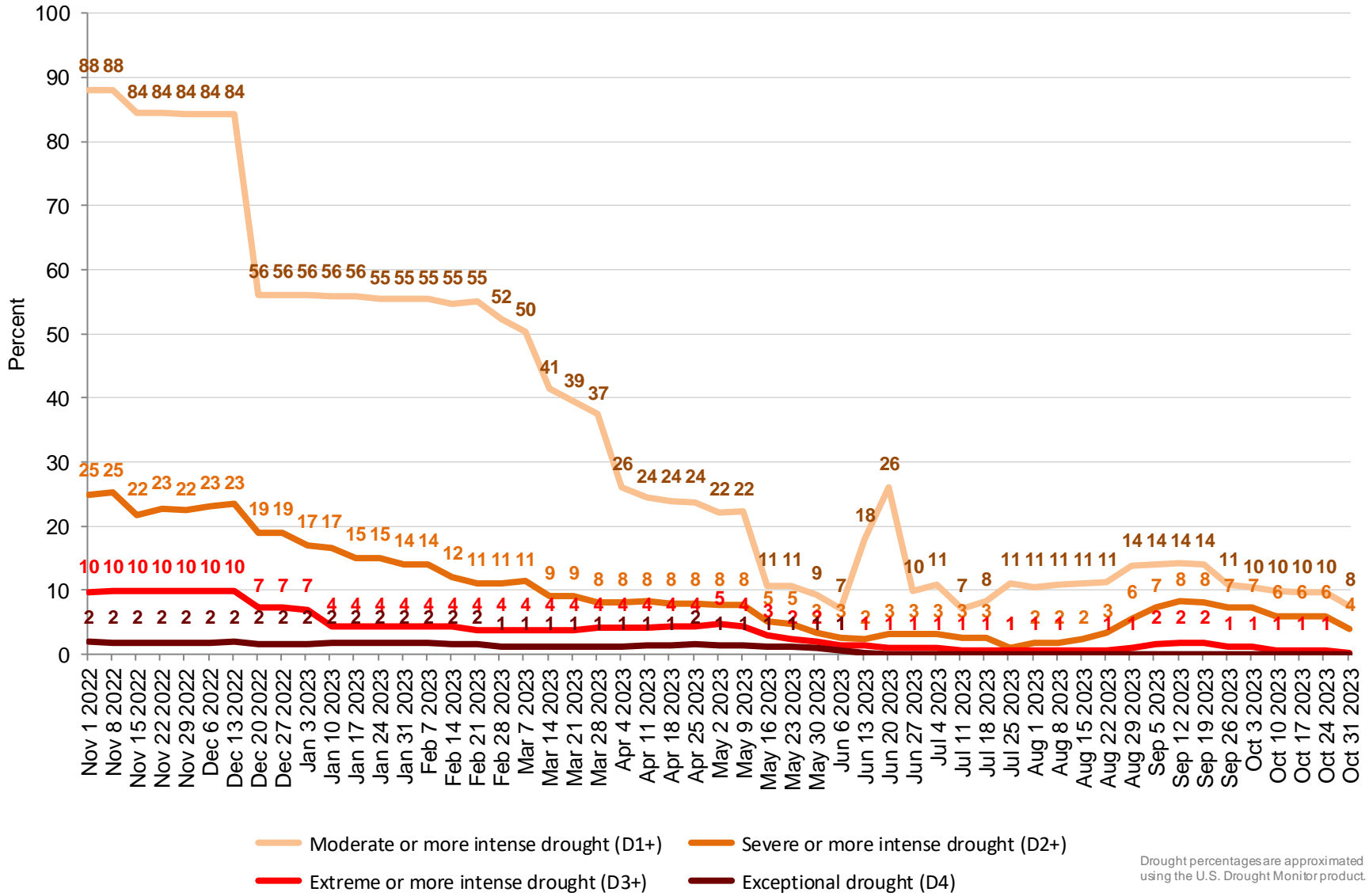

Percent of United States Sunflowers Located in Drought

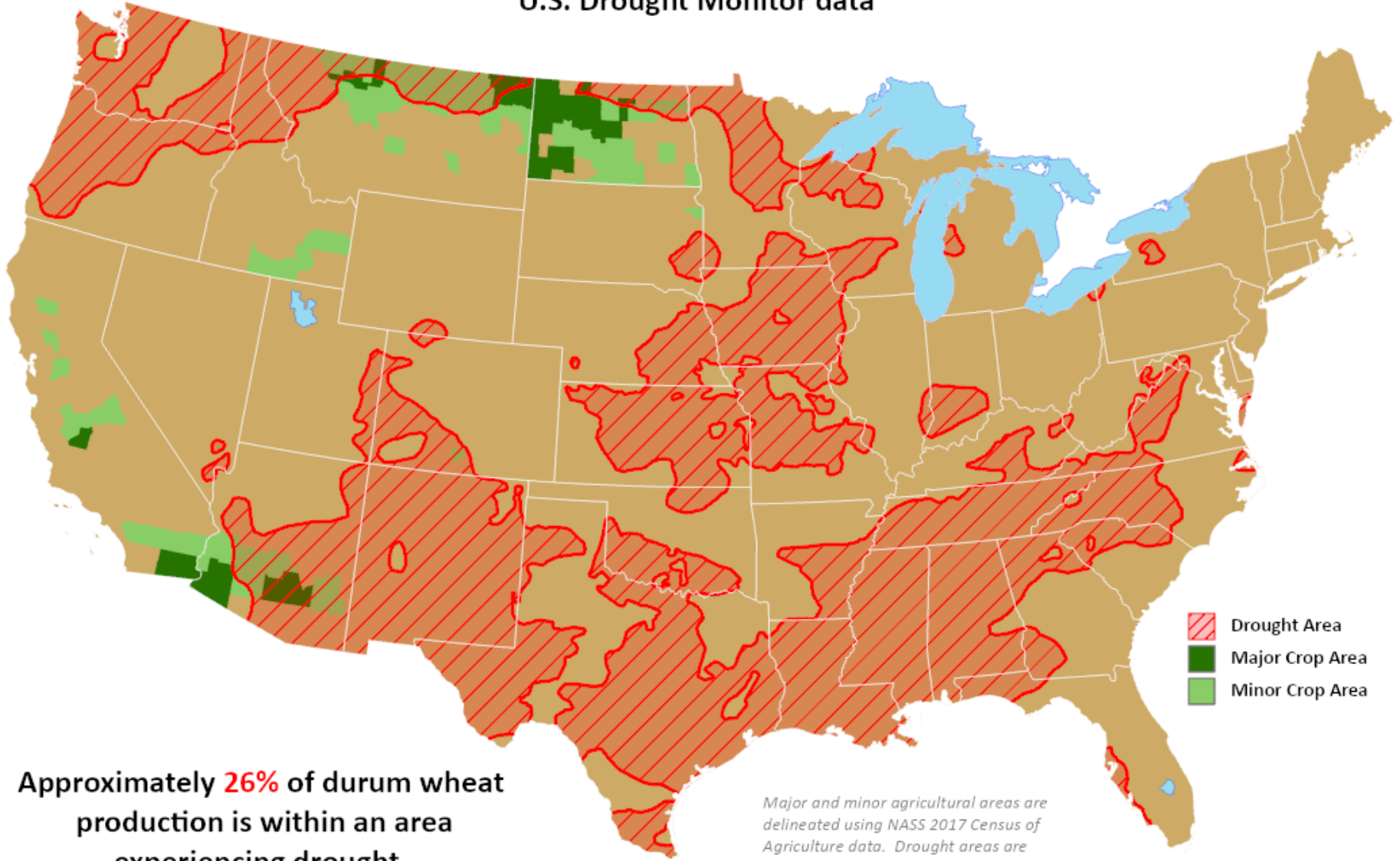

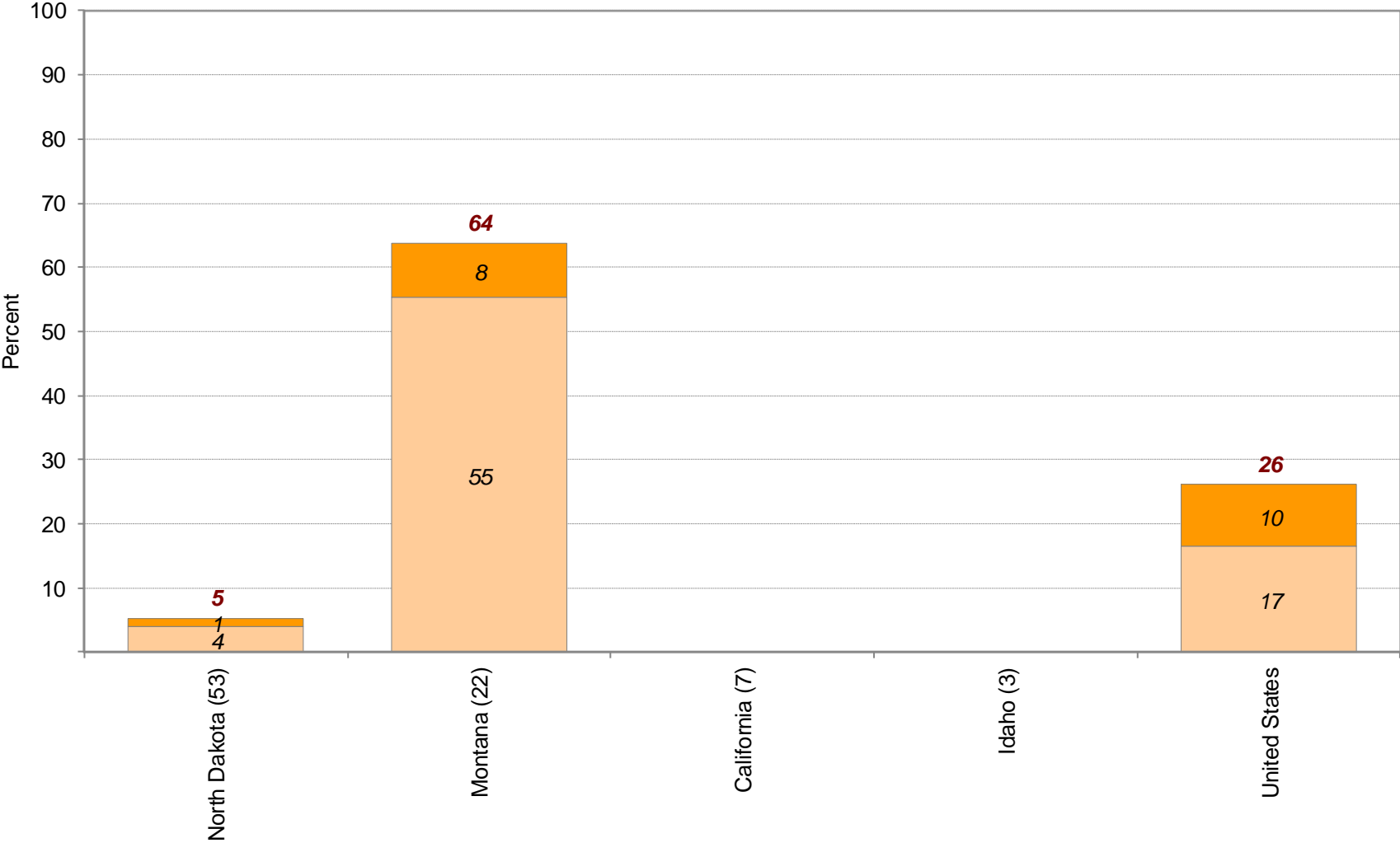

Percent of Durum Wheat Located in Drought

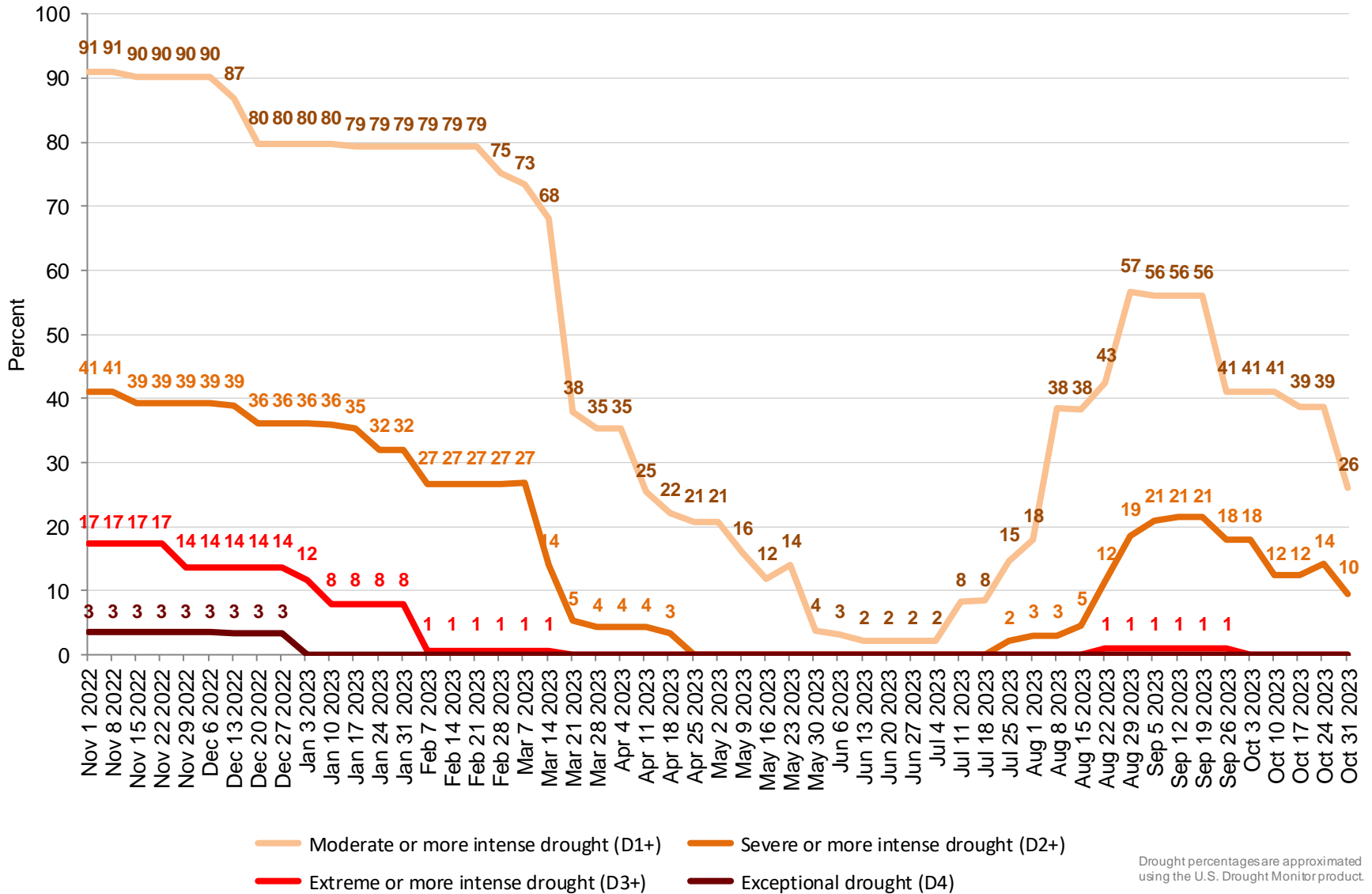

Percent of United States Durum Wheat Located in Drought

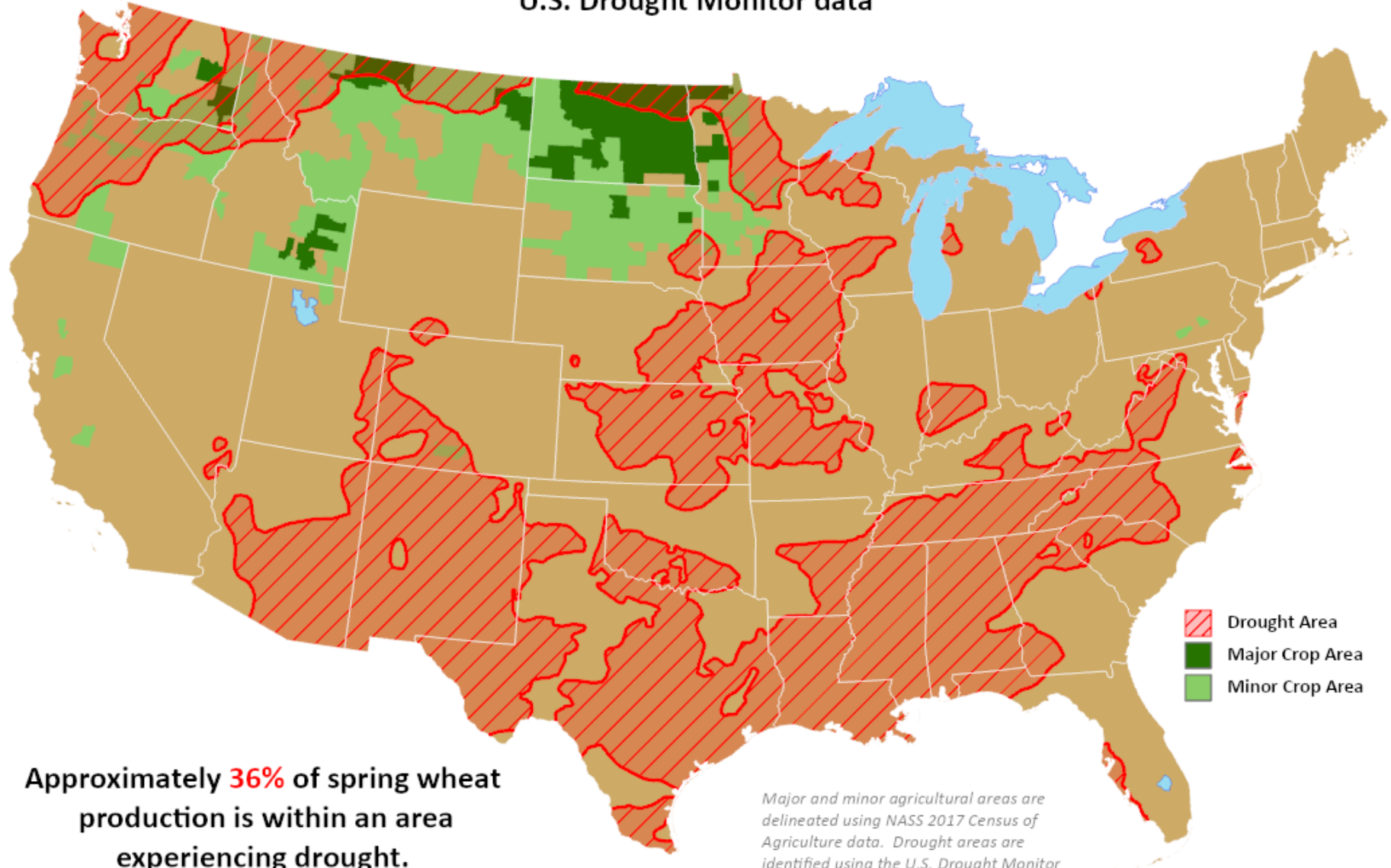

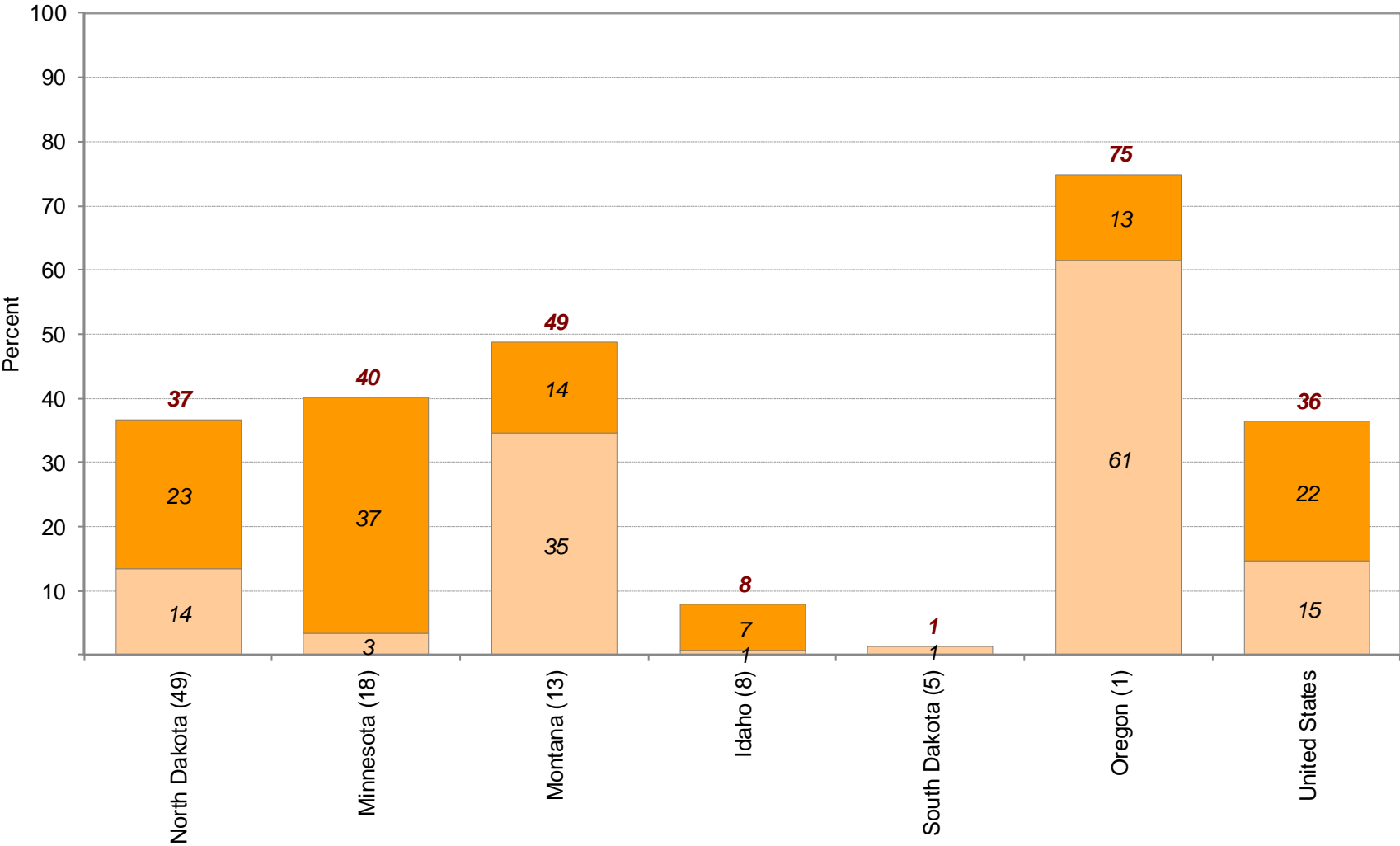

Percent of Spring Wheat Located in Drought

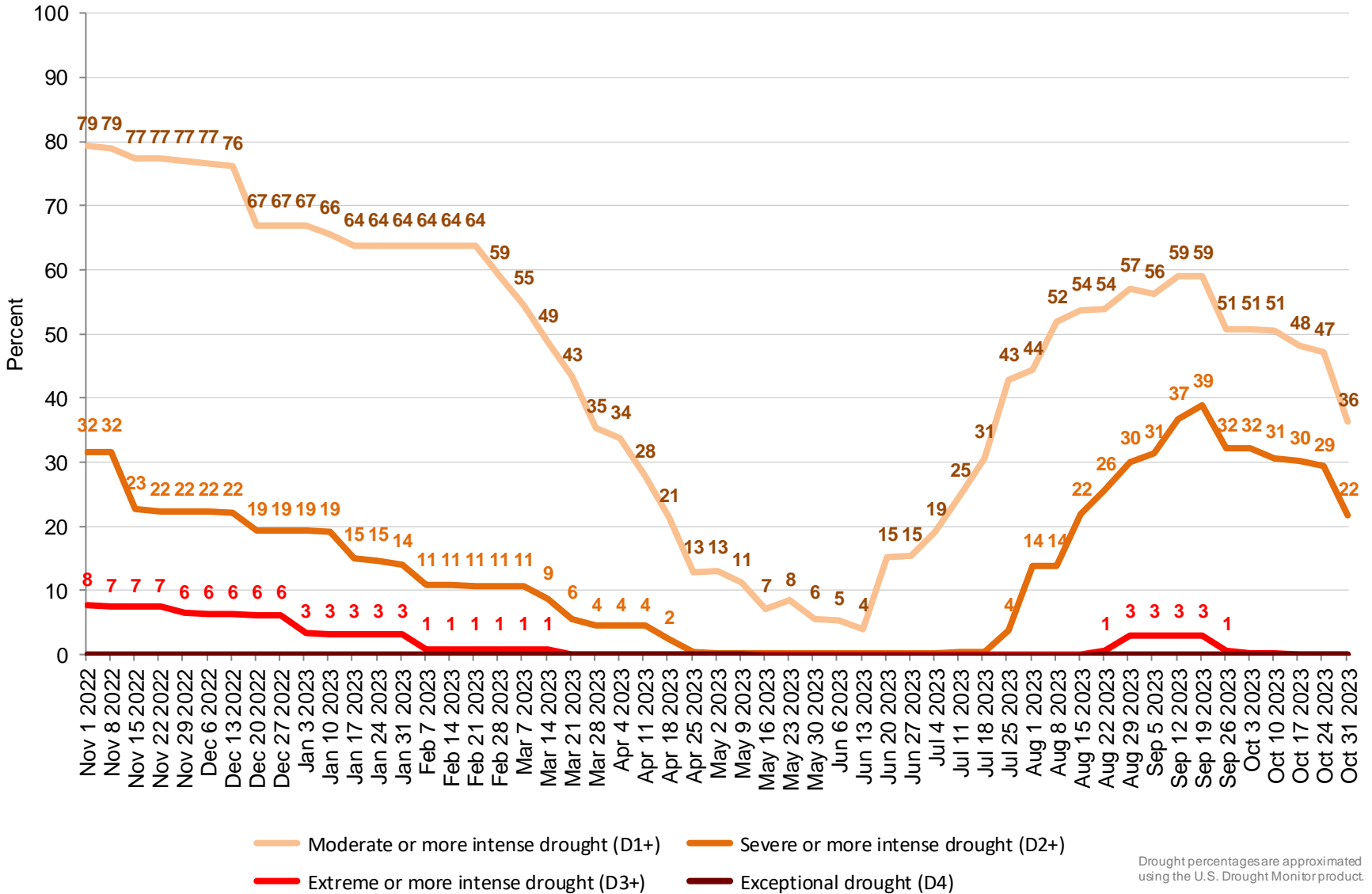

Percent of United States Spring Wheat Located in Drought

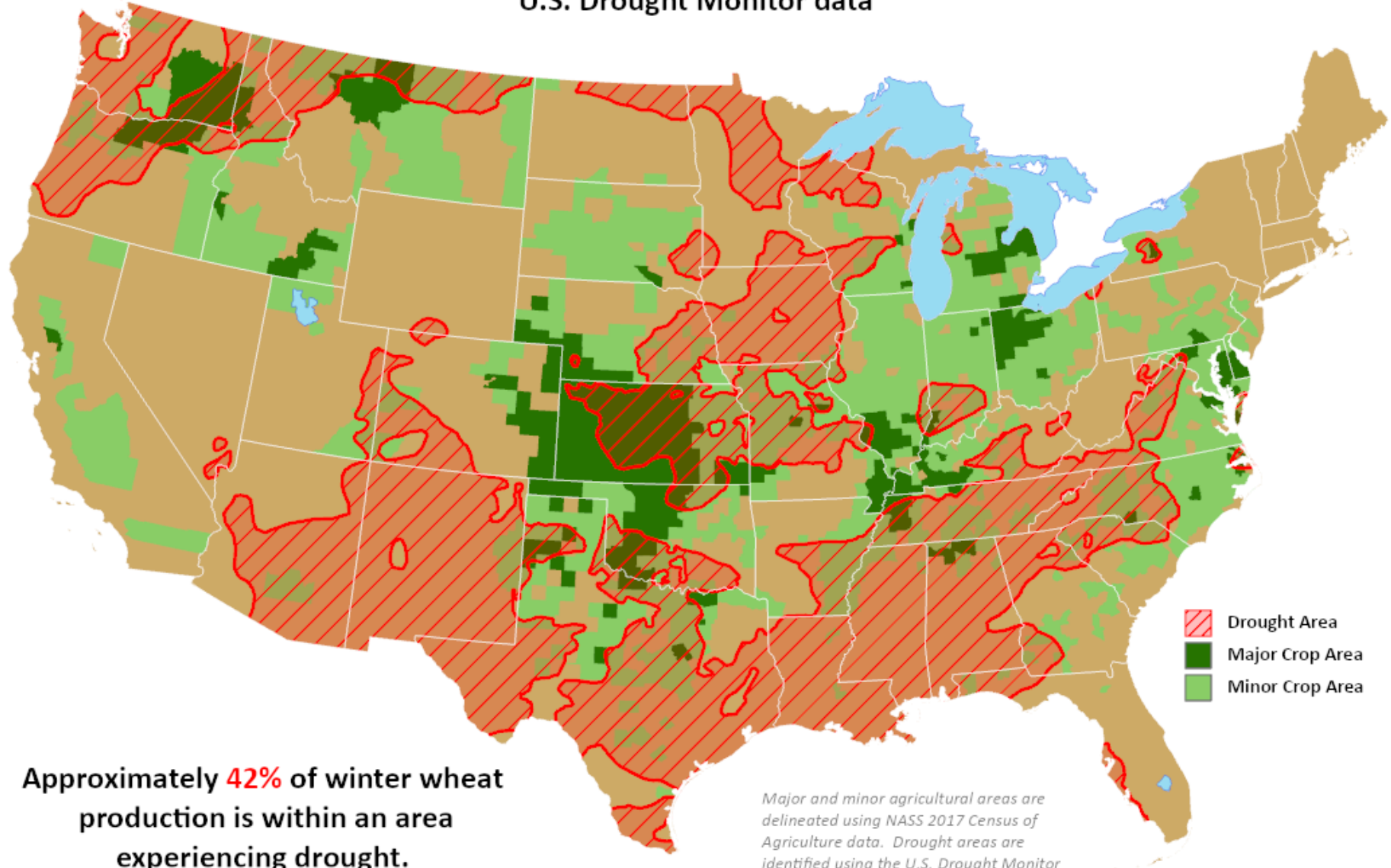

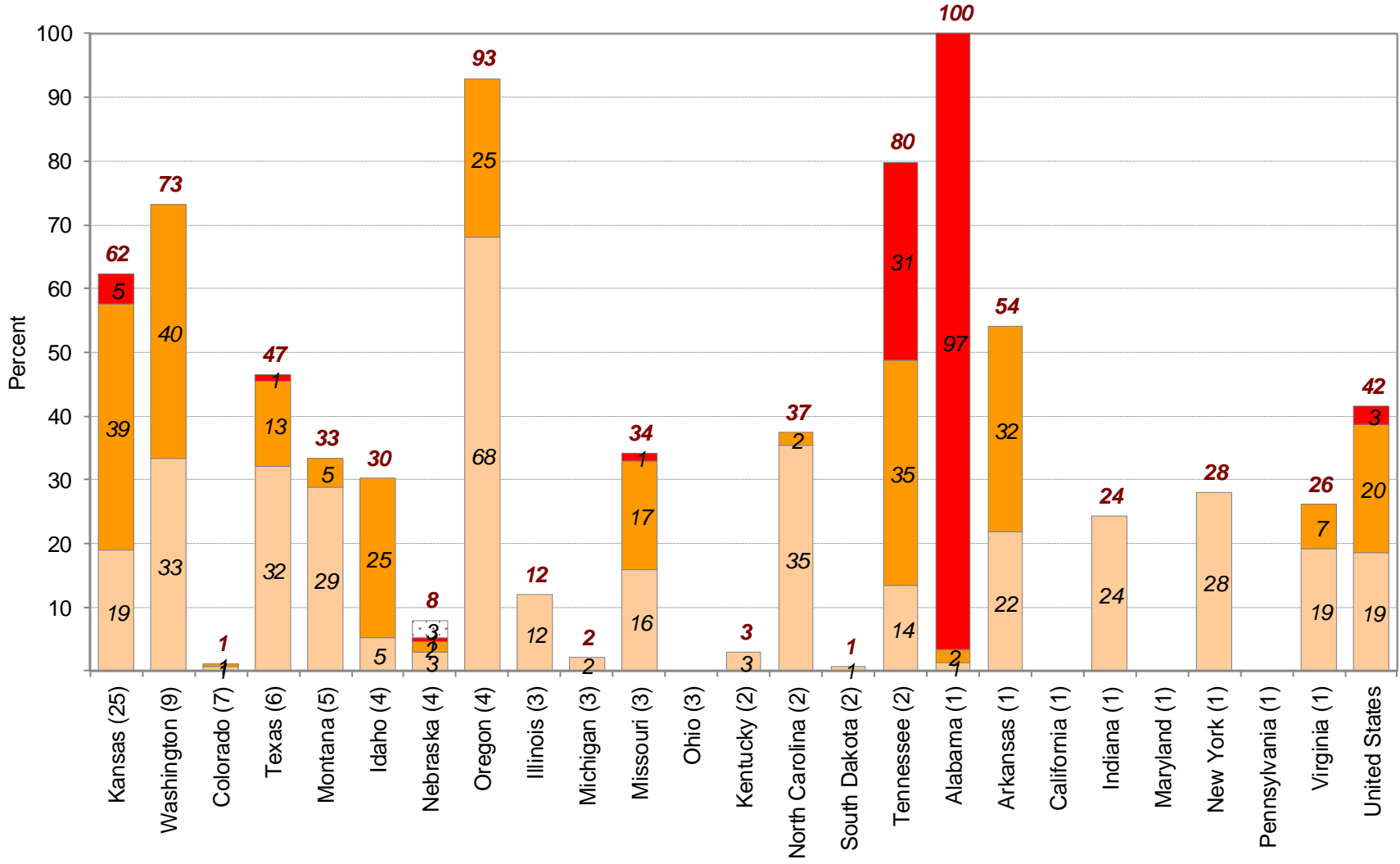

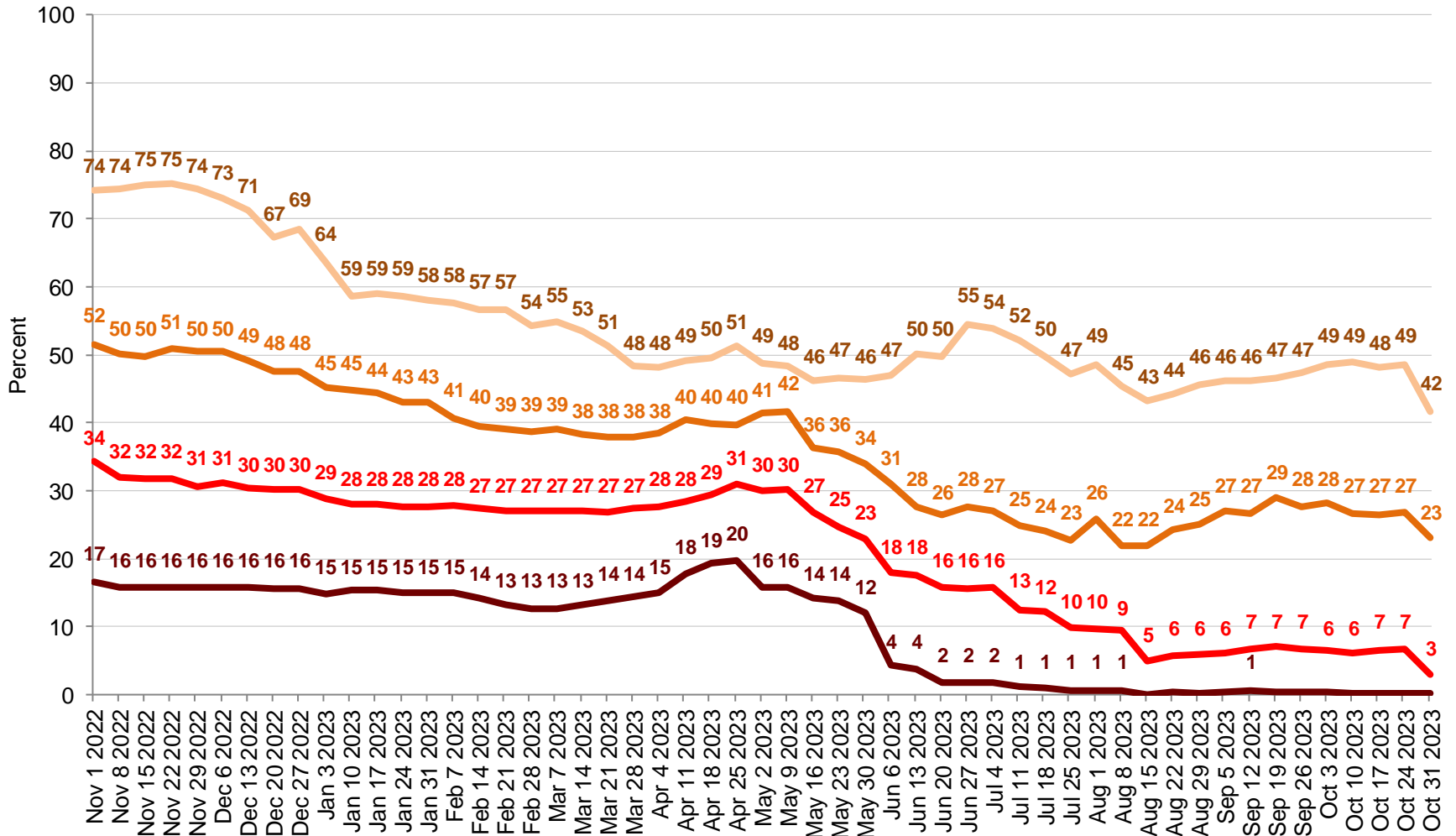
Percent of Winter Wheat Located in Drought October 31, 2023

Percent of United States Winter Wheat Located in Drought

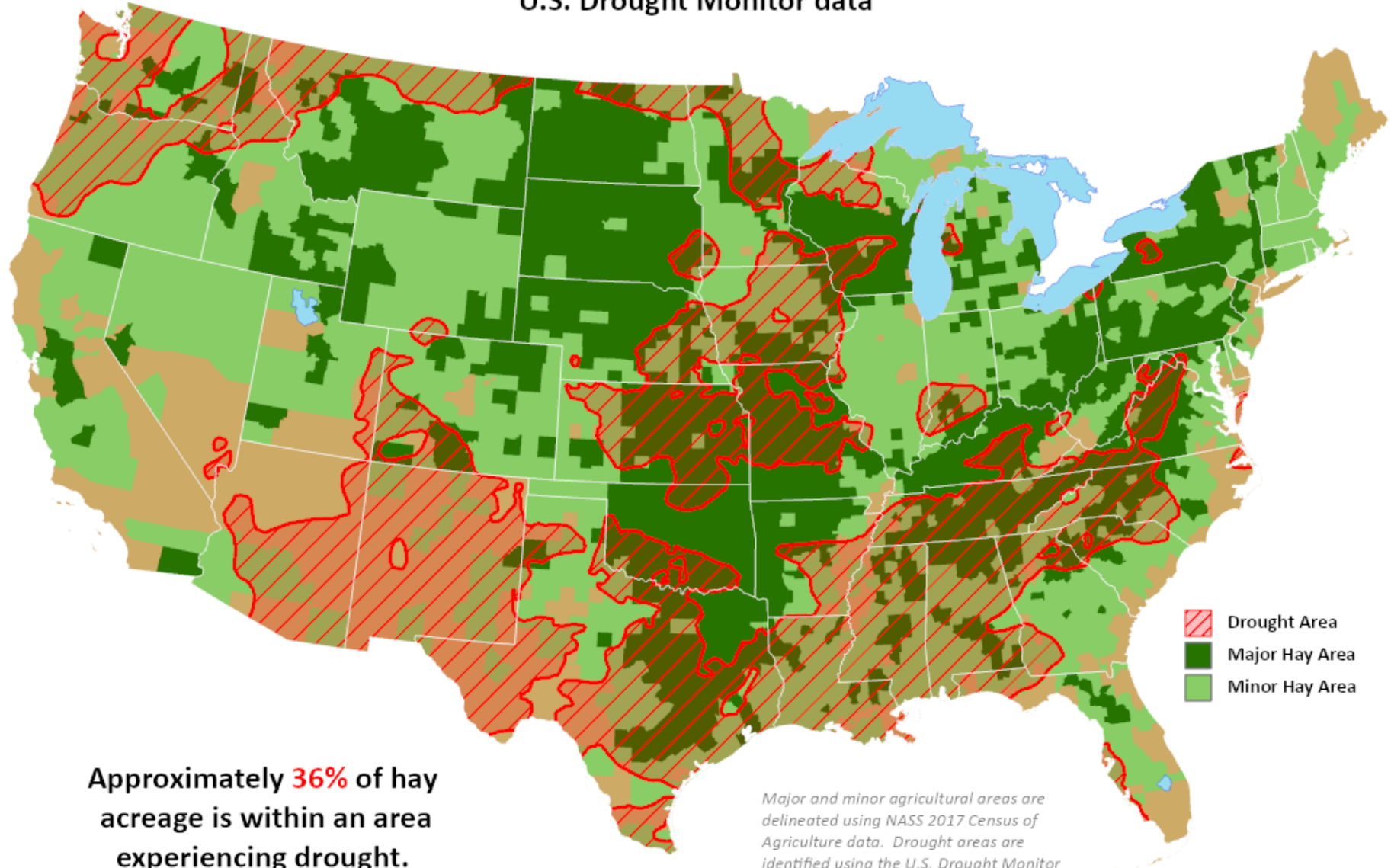

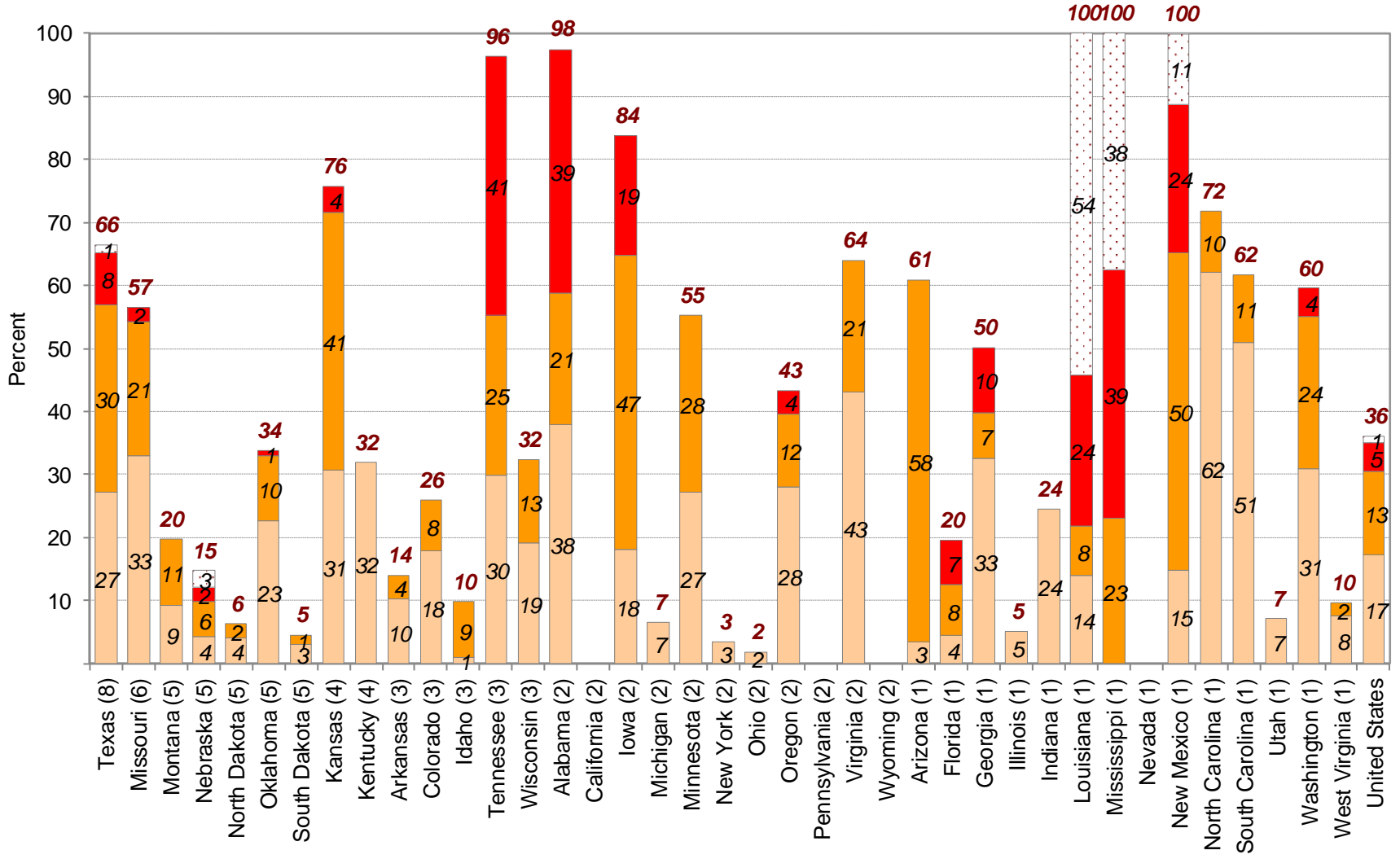

Percent of Hay Located in Drought

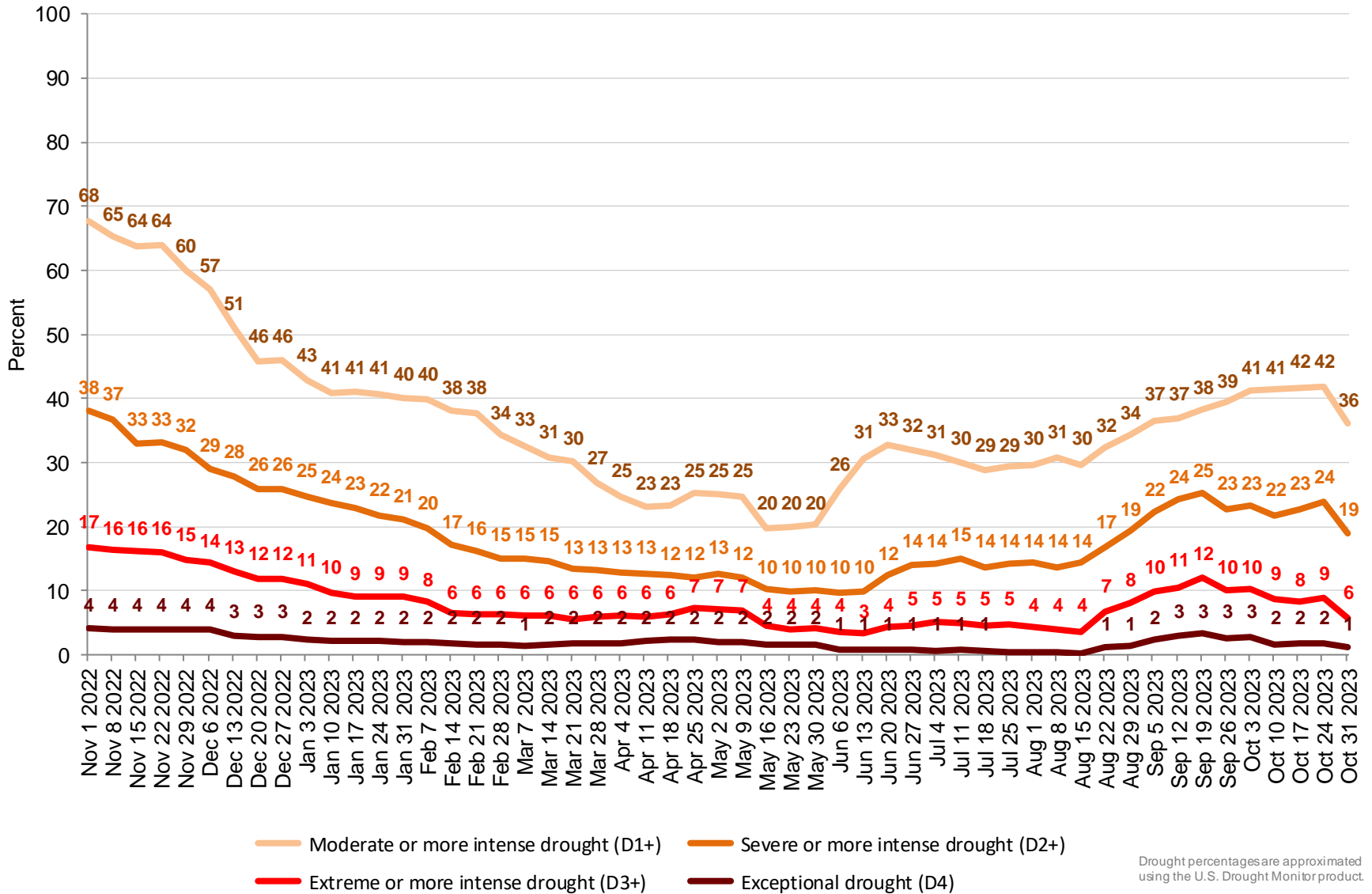

Percent of United States Hay Located in Drought

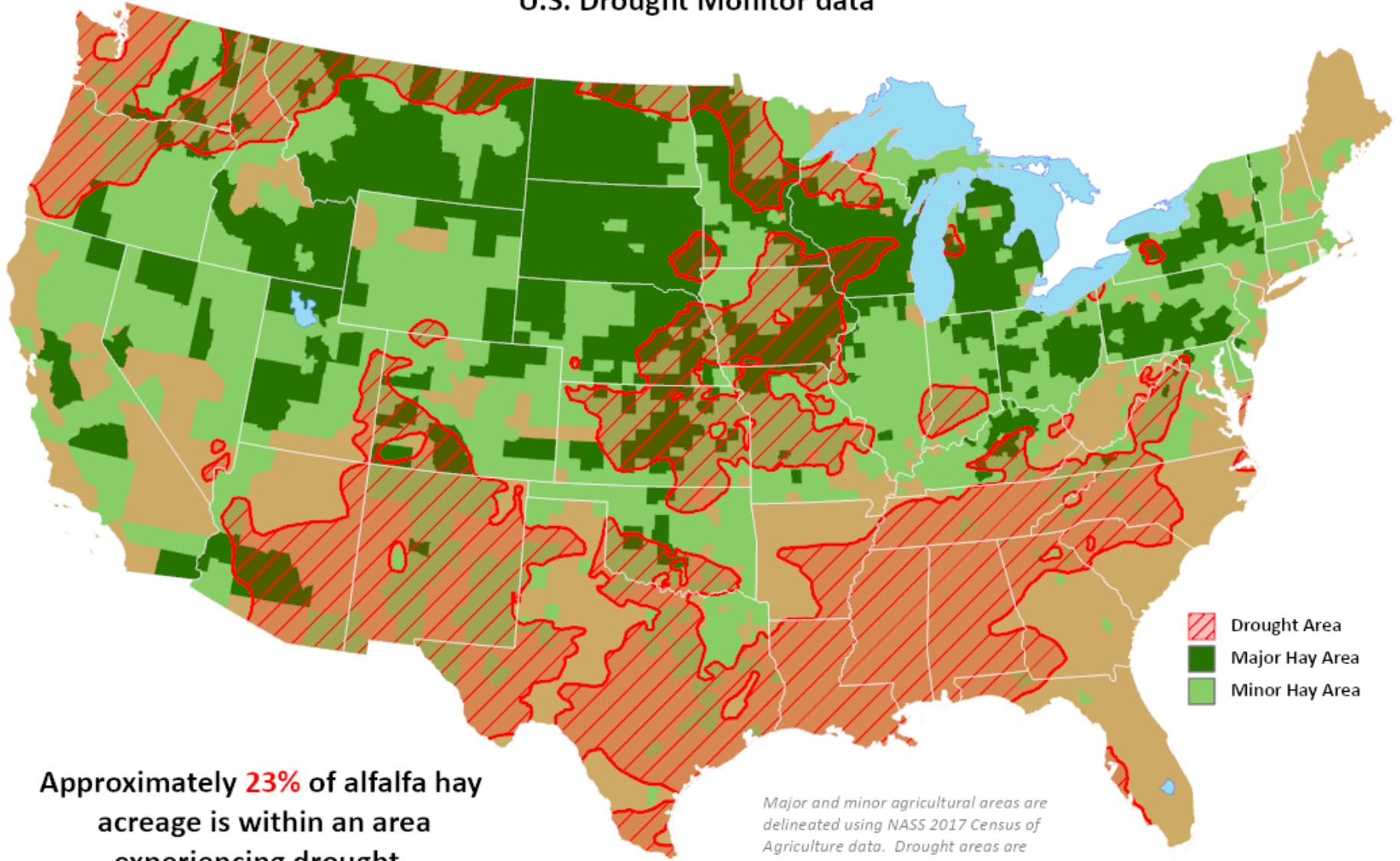

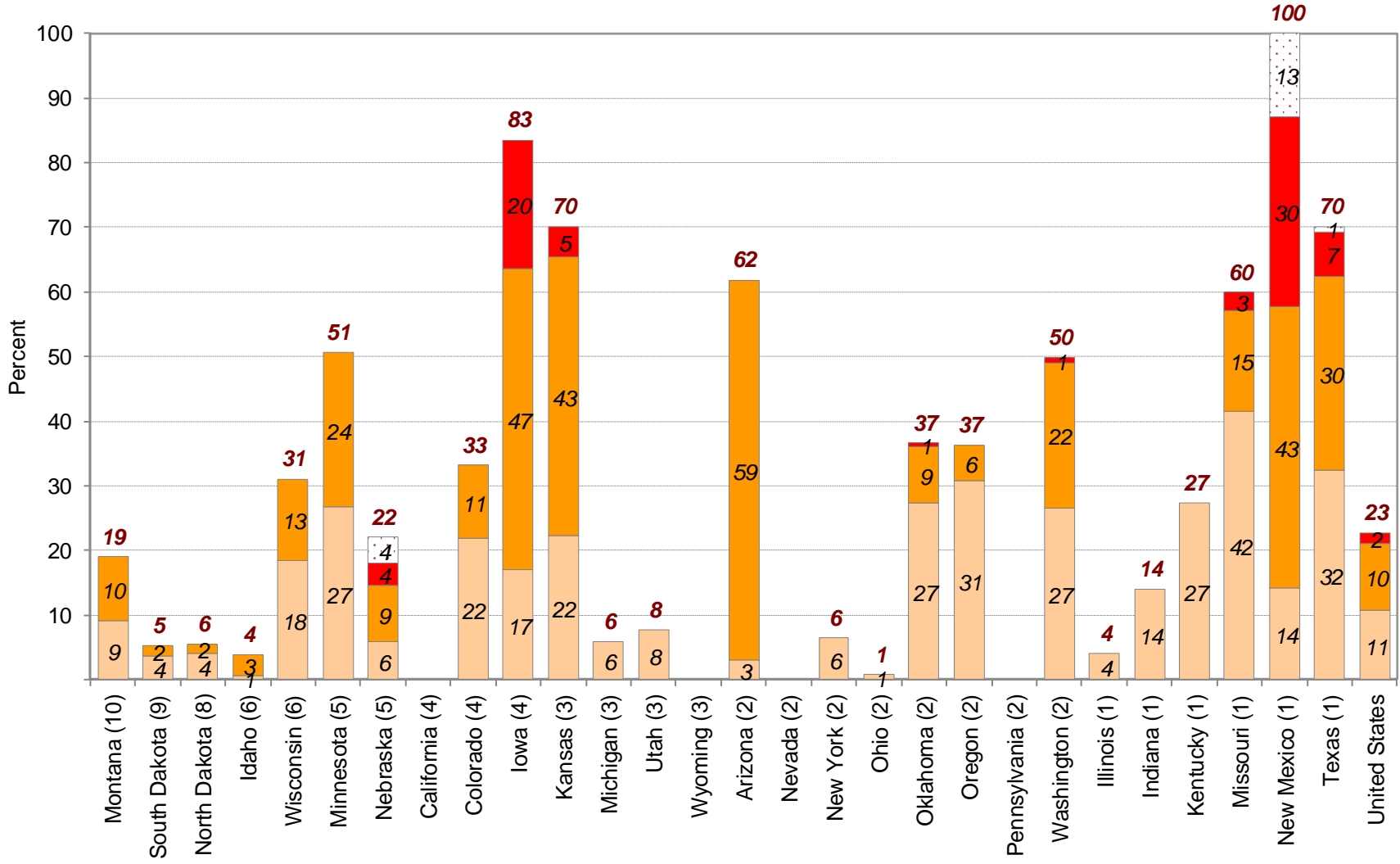

Percent of Alfalfa Hay Located in Drought

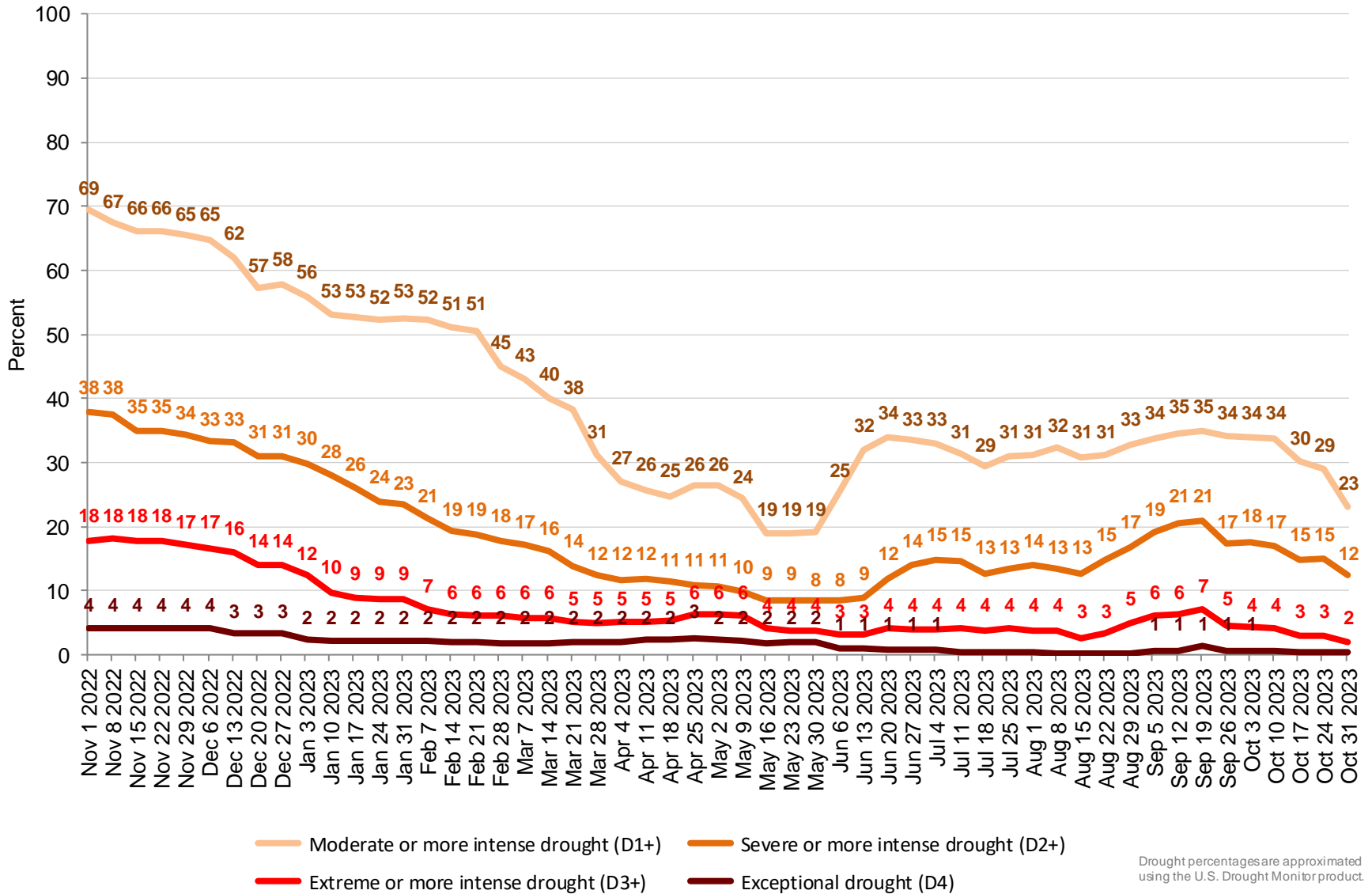

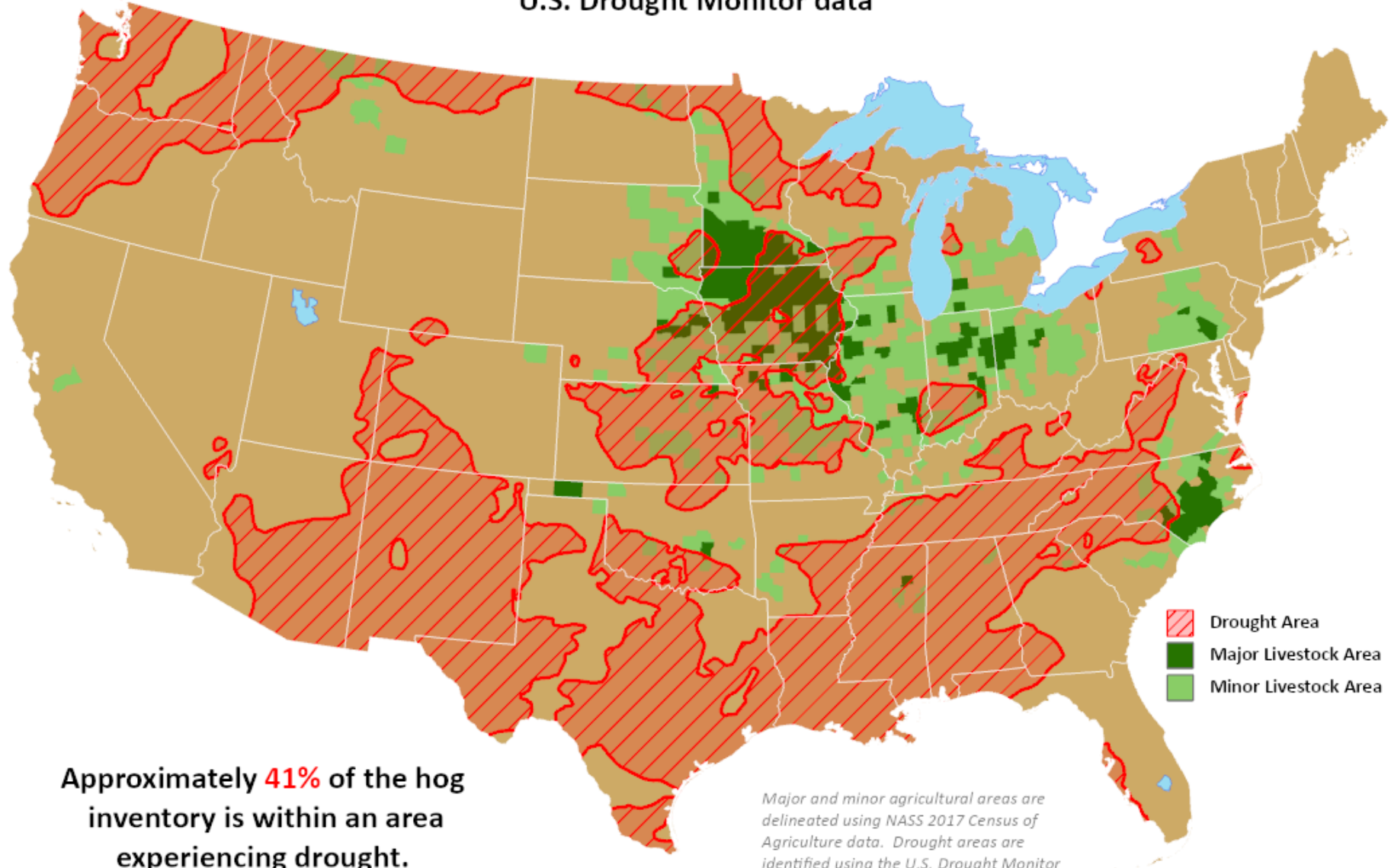
Percent of United States Alfalfa Hay Located in Drought

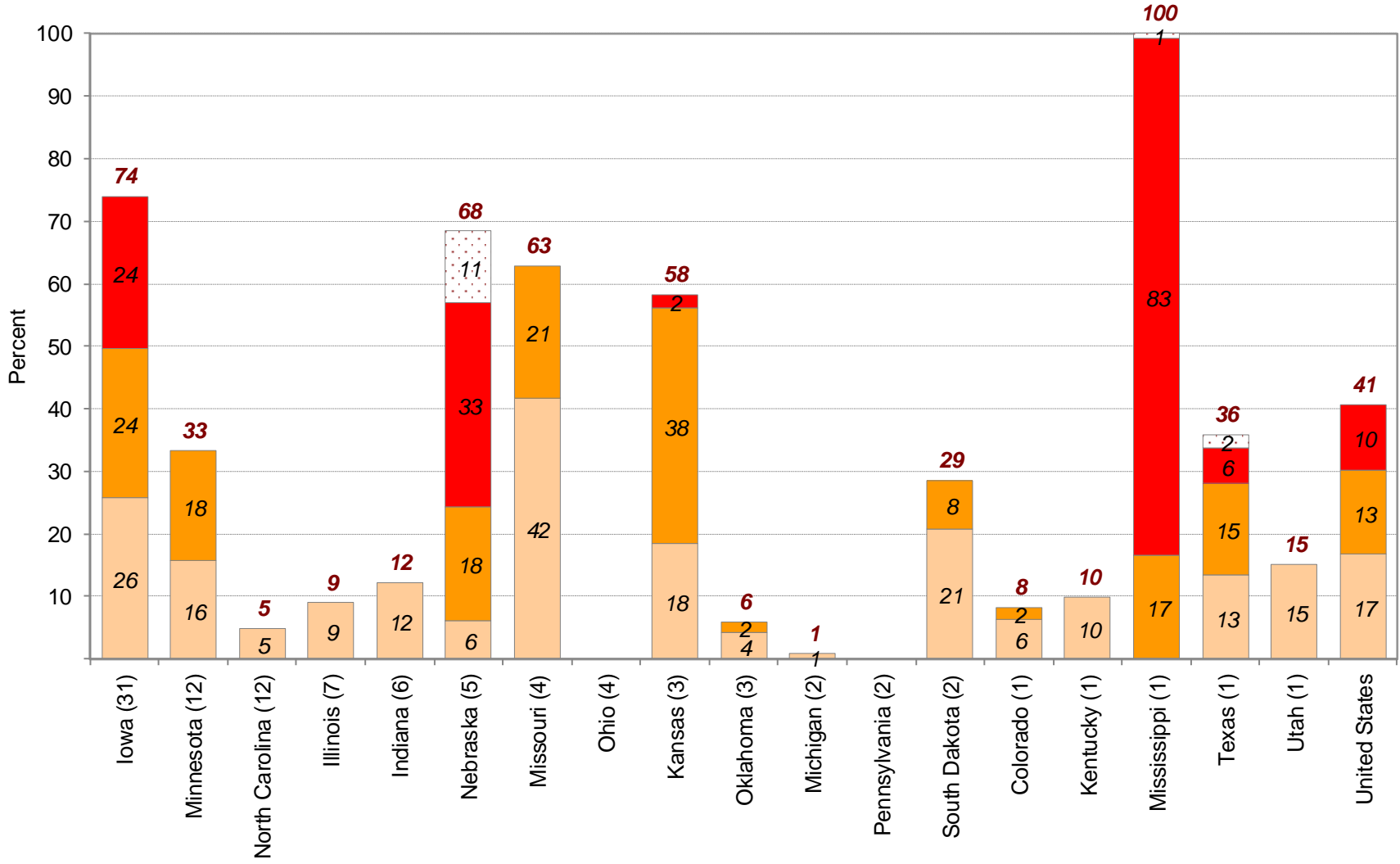

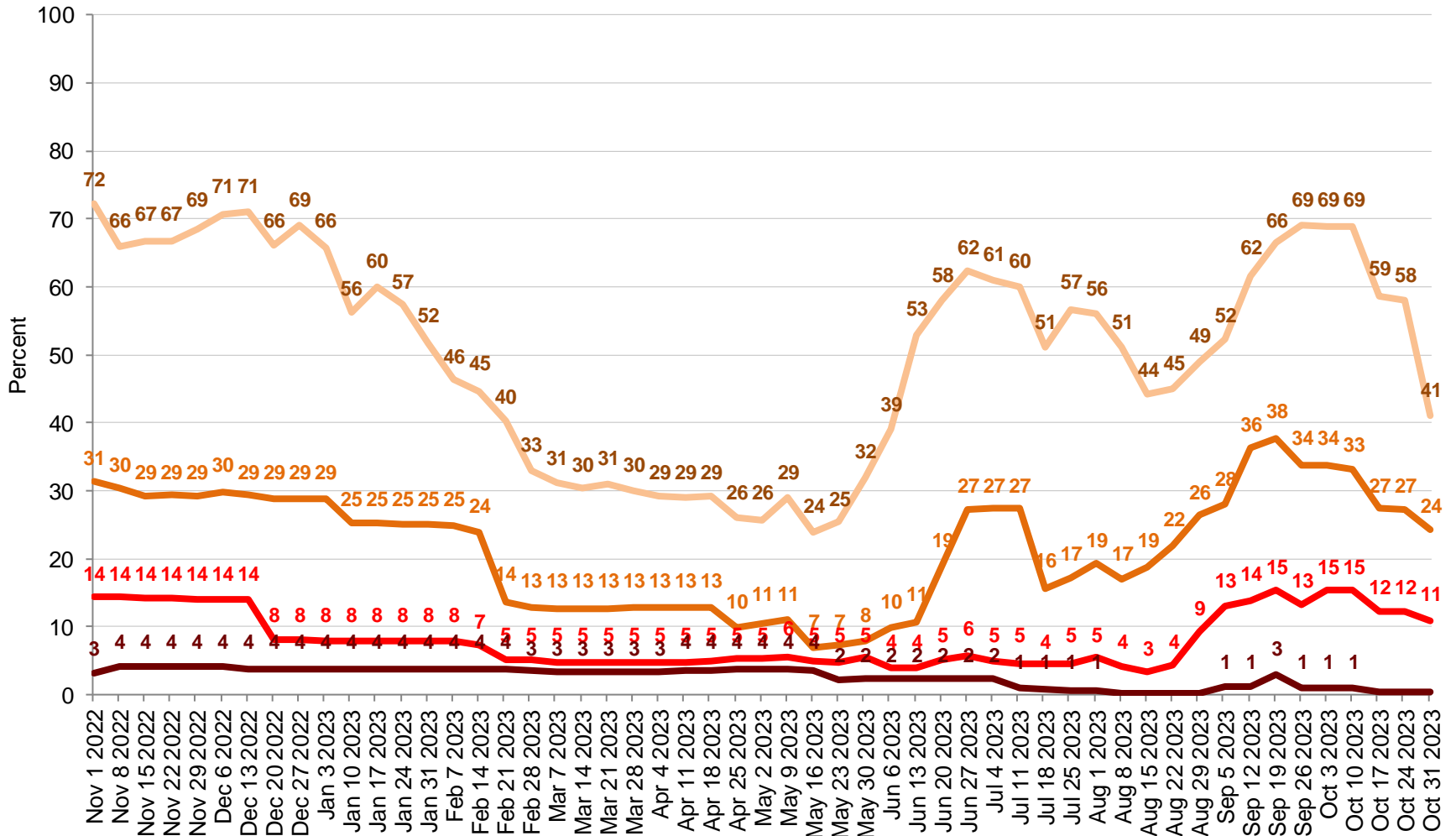
Percent of Hogs Located in Drought October 31, 2023

Percent of United States Hogs Located in Drought

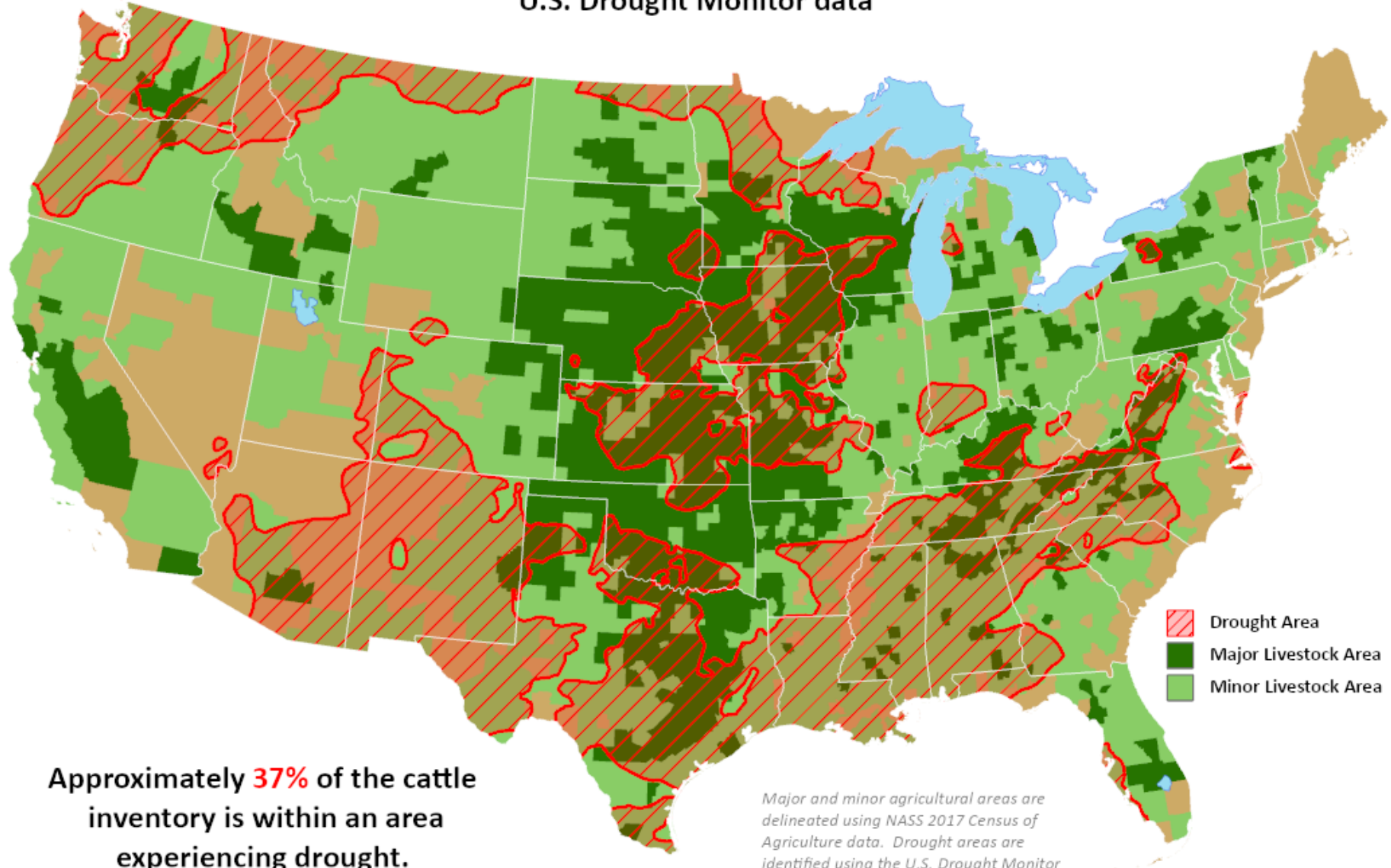

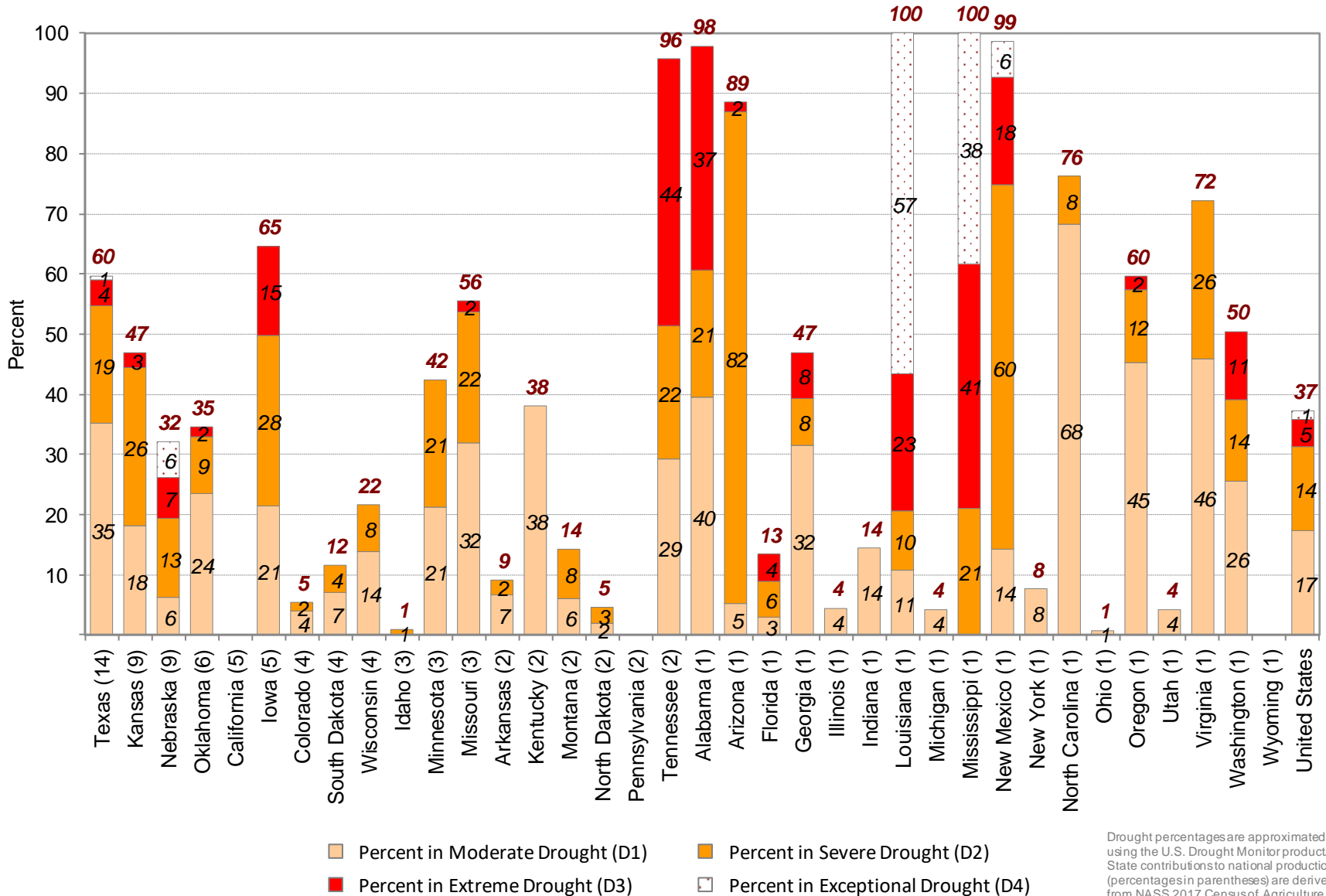

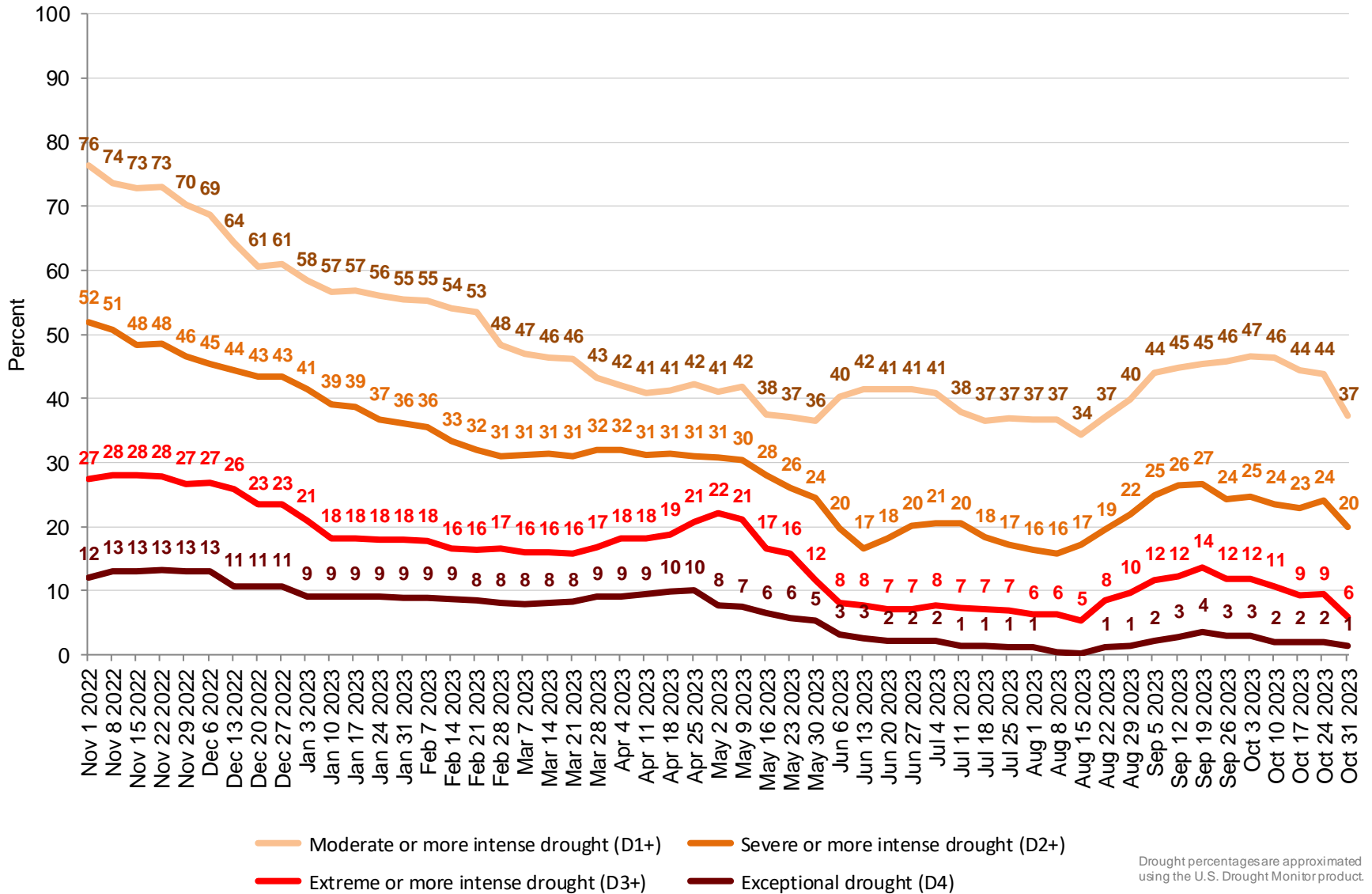
Percent of Cattle Located in Drought

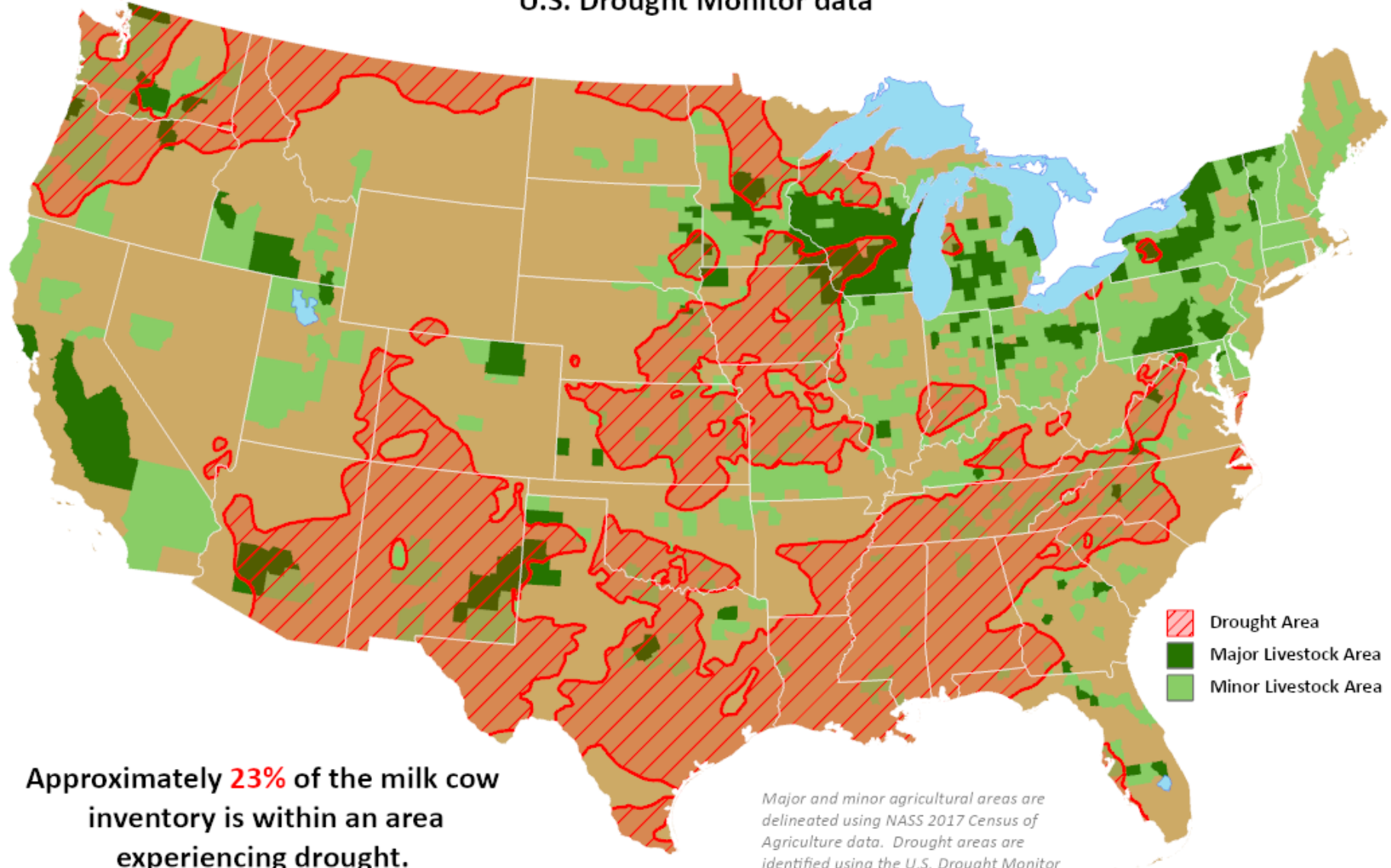
Percent of United States Cattle Located in Drought

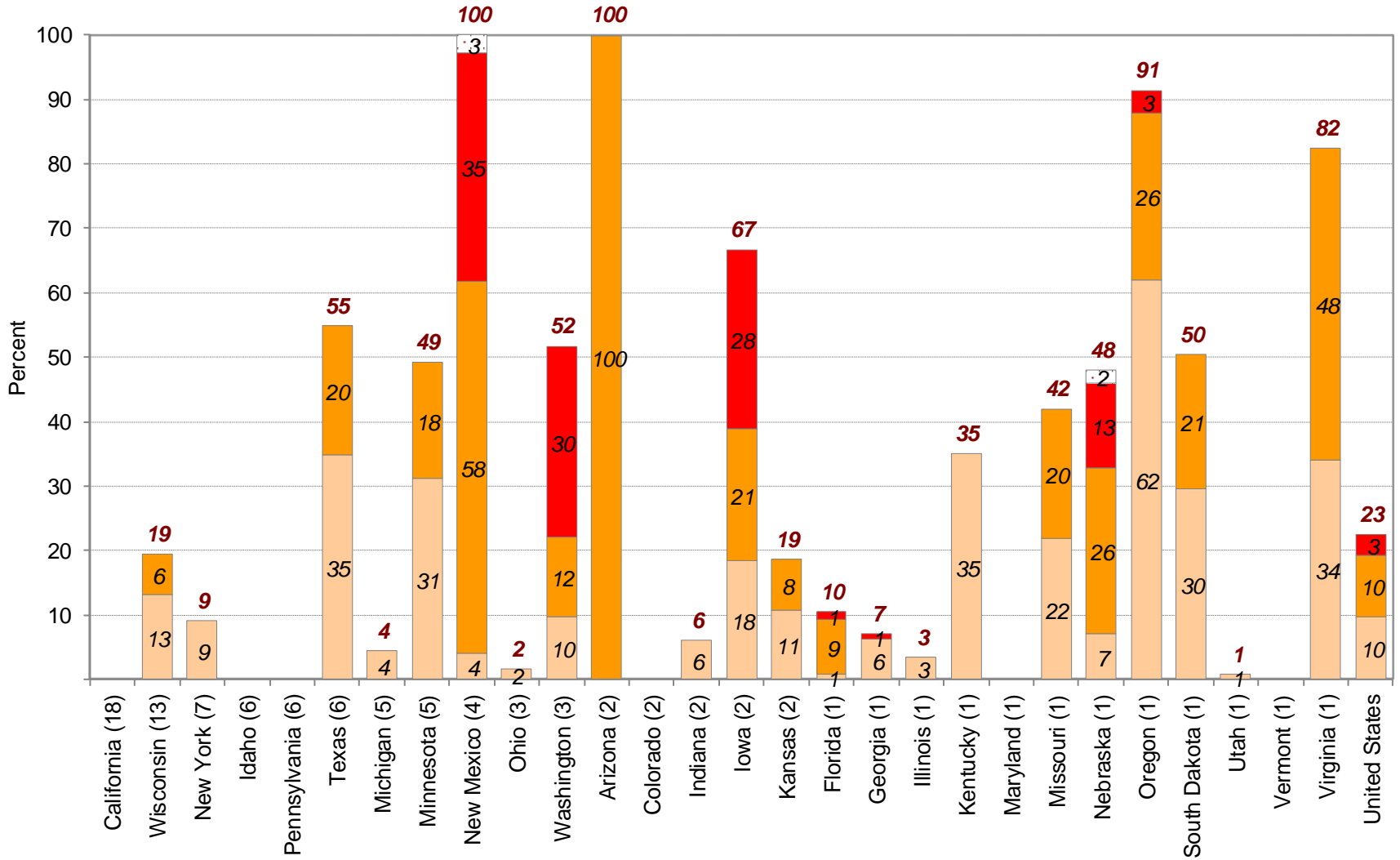

Percent of Milk Cows Located in Drought

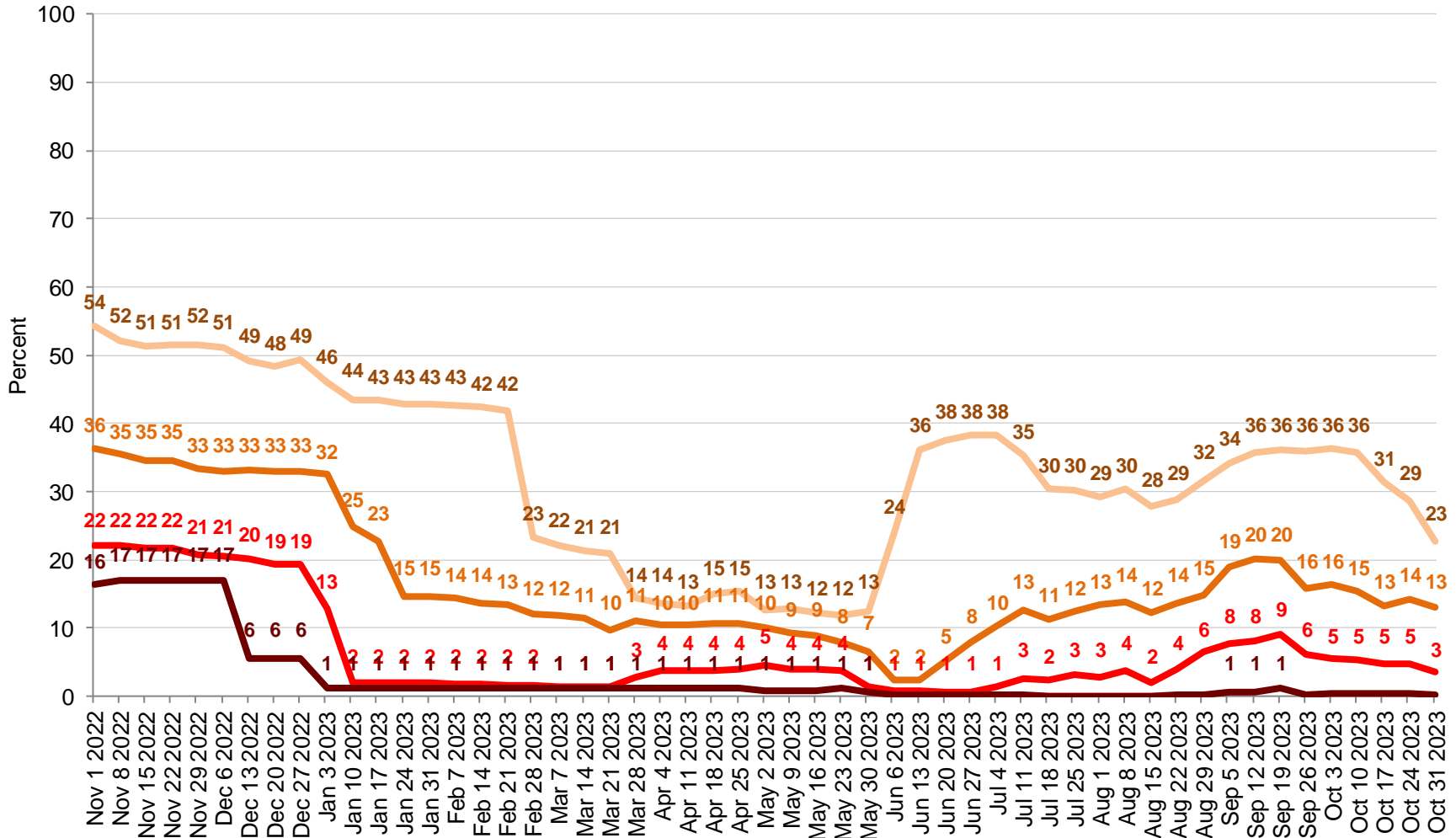

Percent of United States Milk Cows Located in Drought

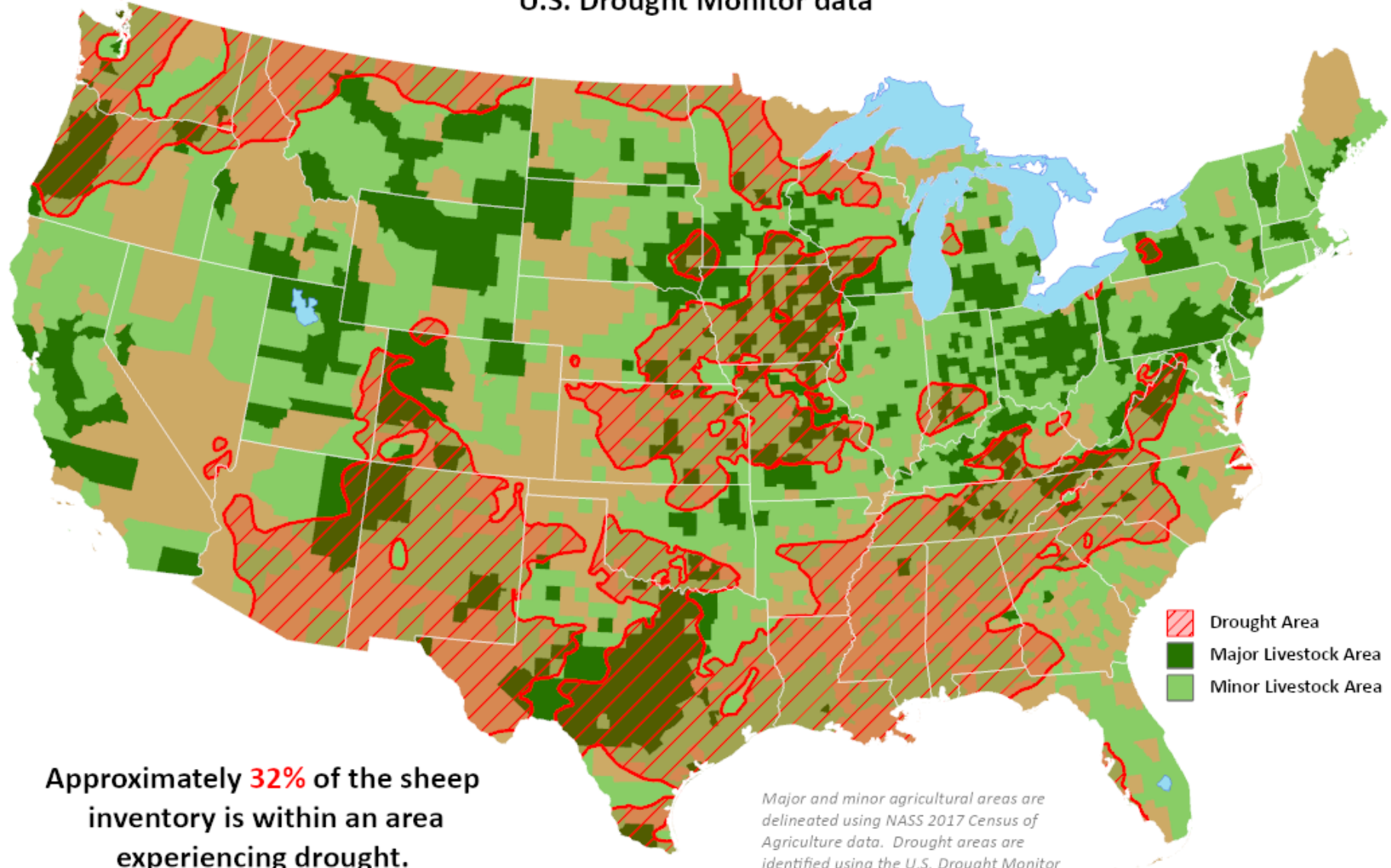

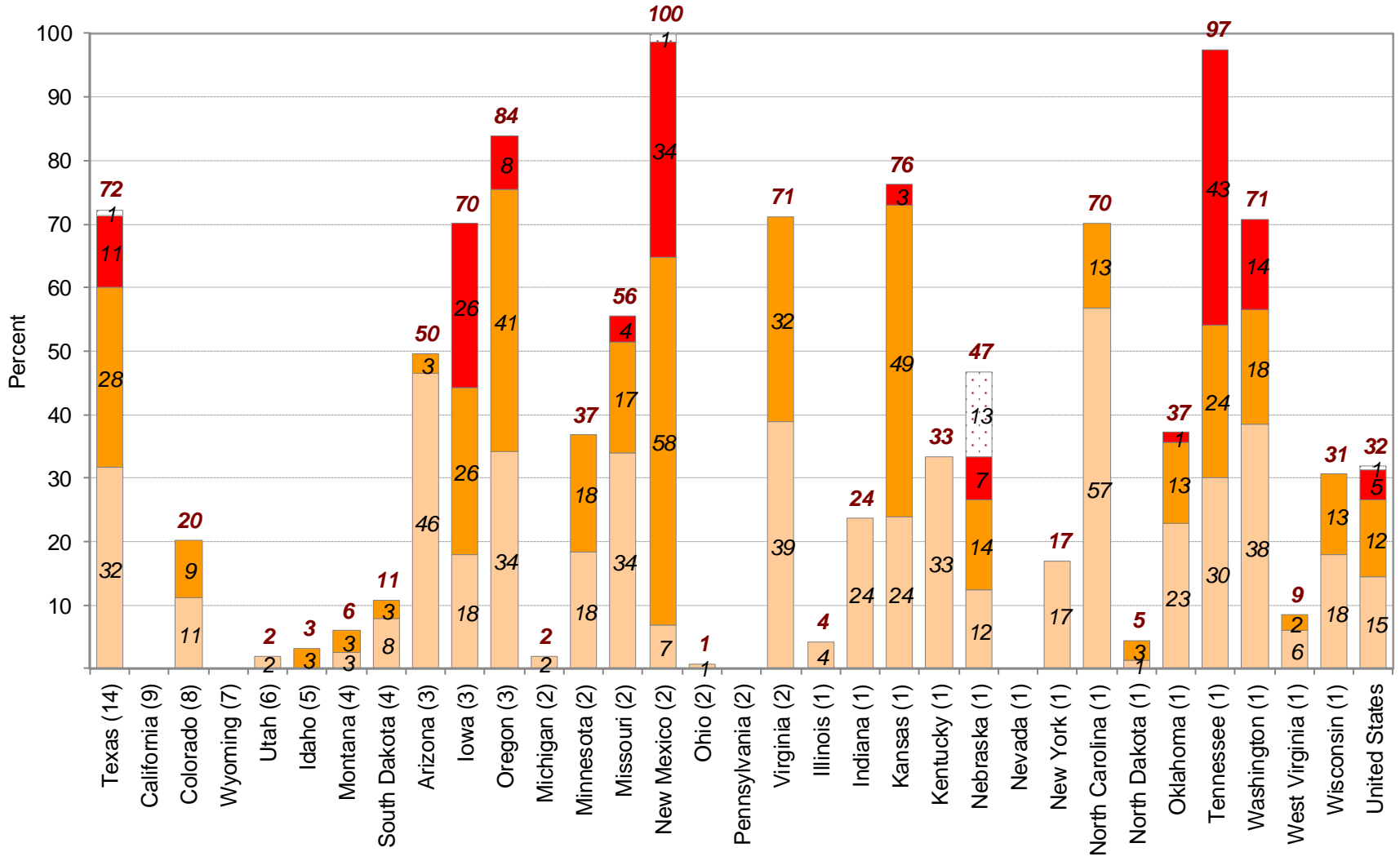

Percent of Sheep Located in Drought

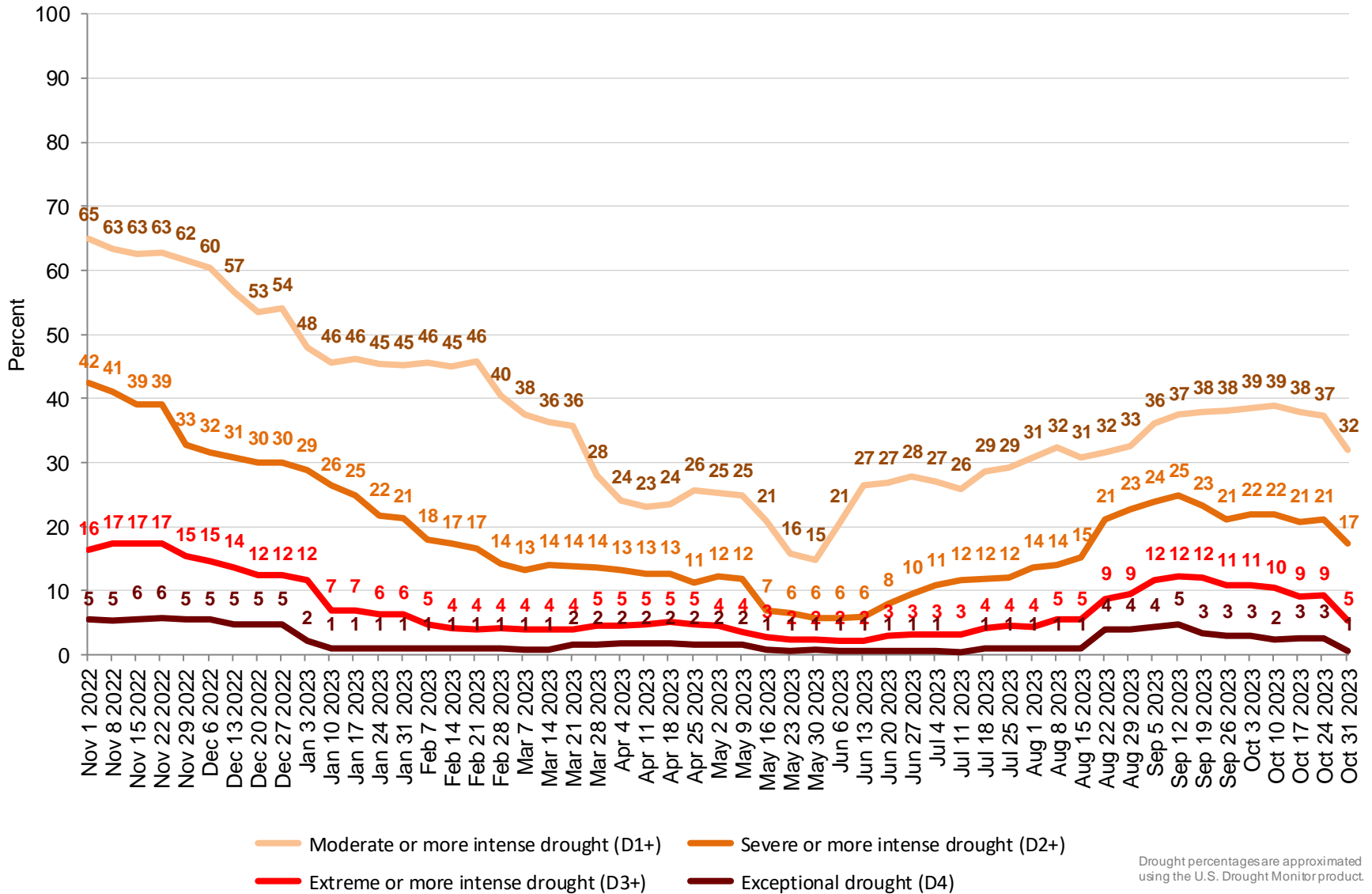

Percent of United States Sheep Located in Drought

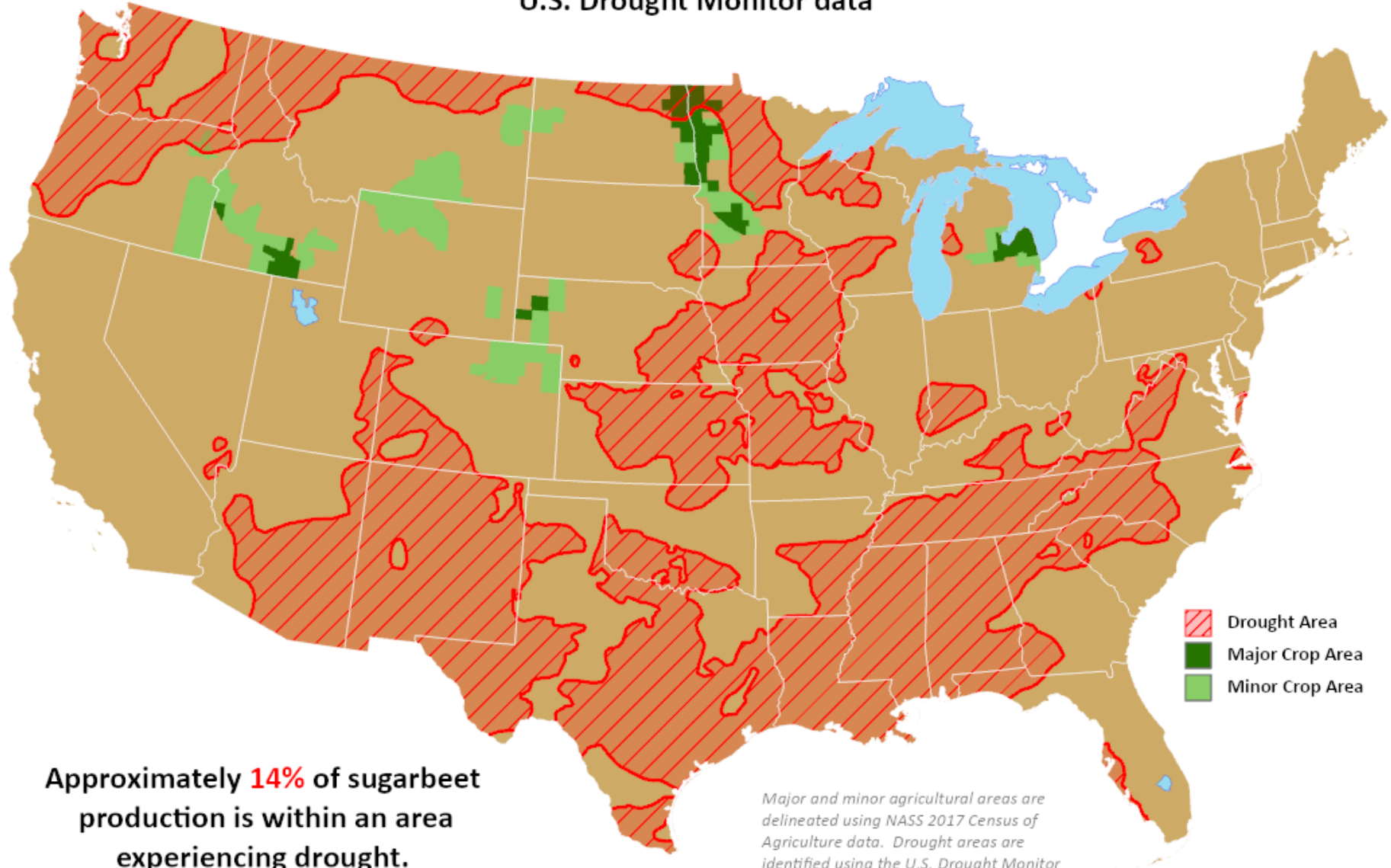

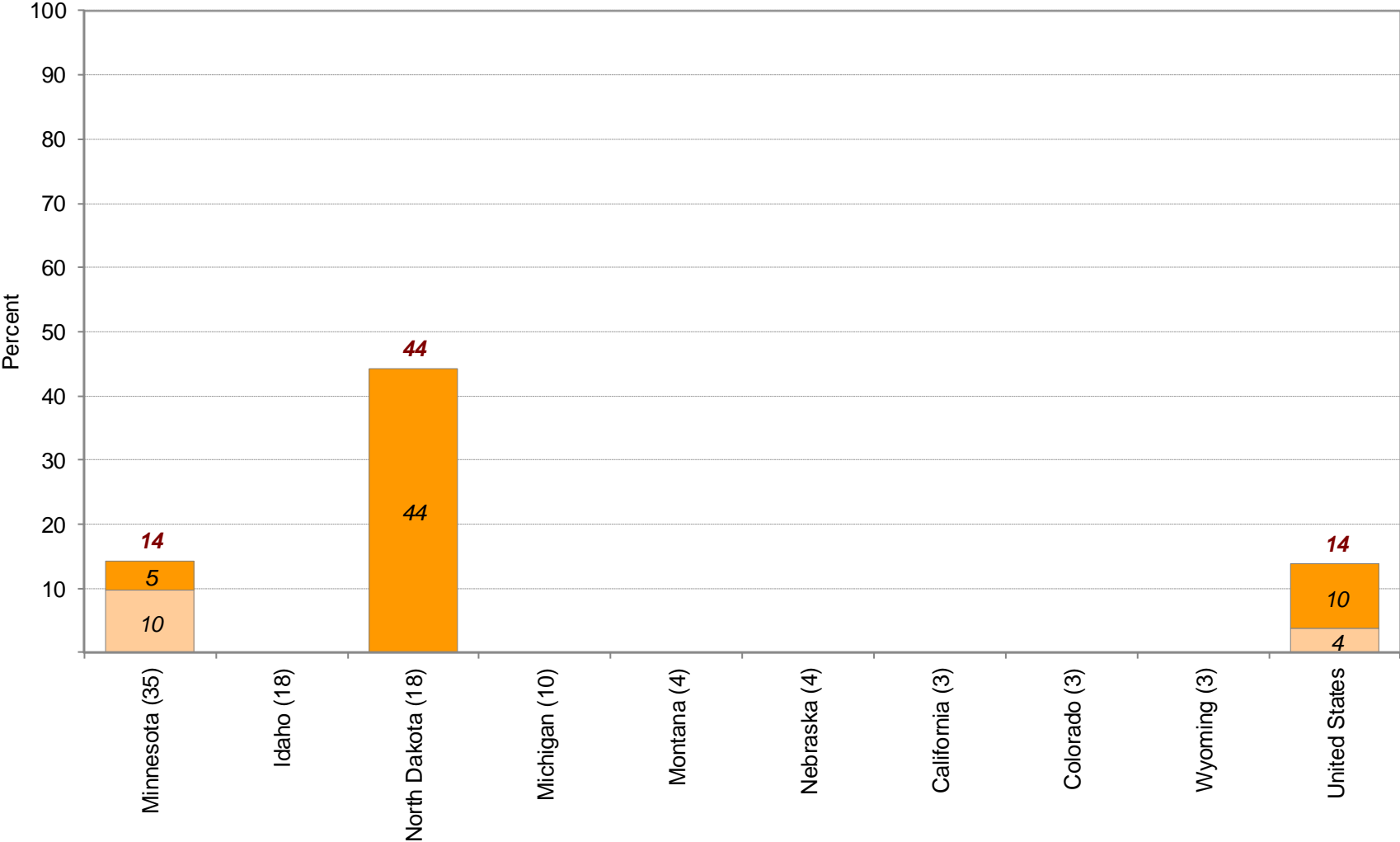

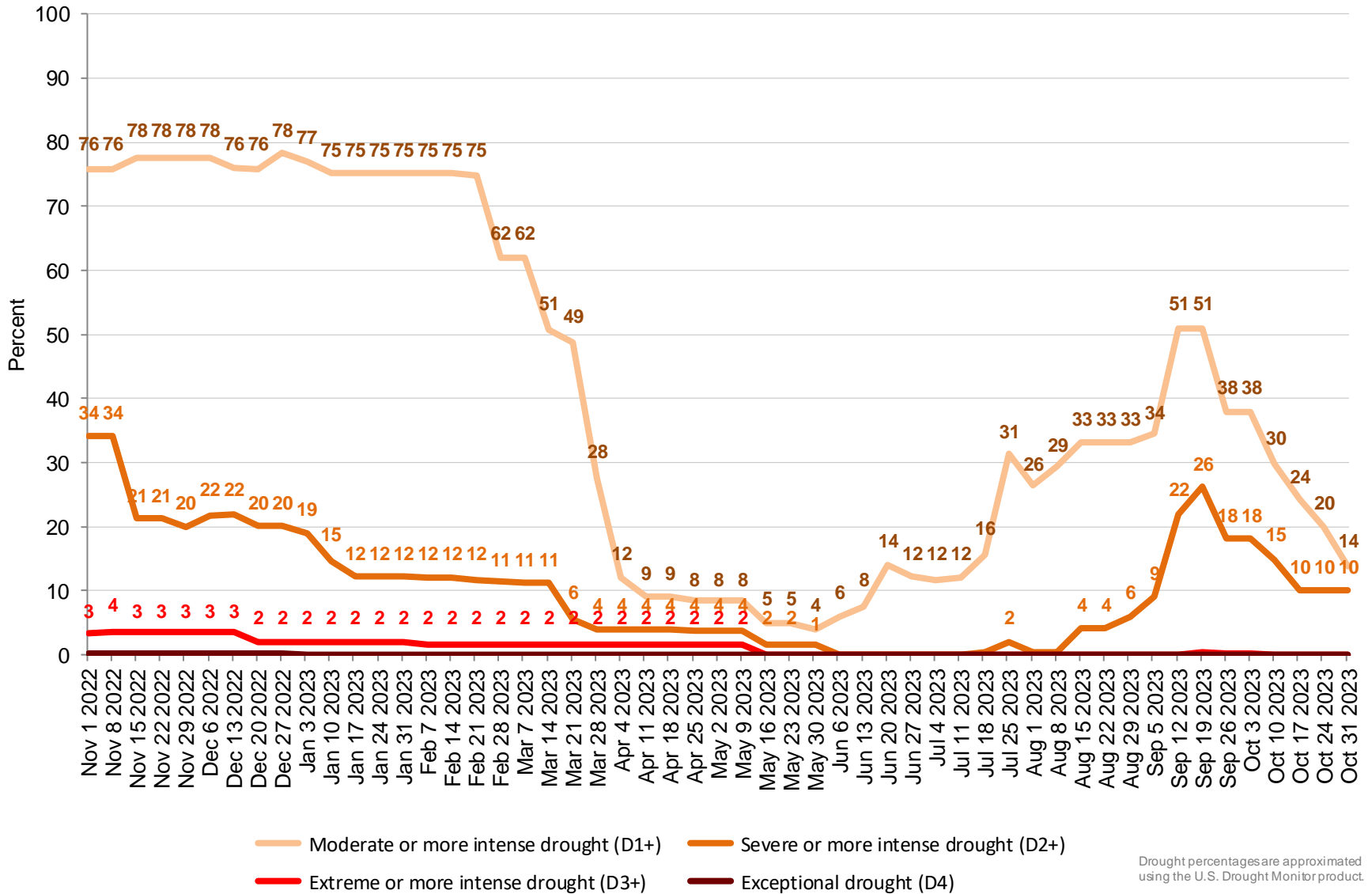

Percent of United States Sugarbeets Located in Drought

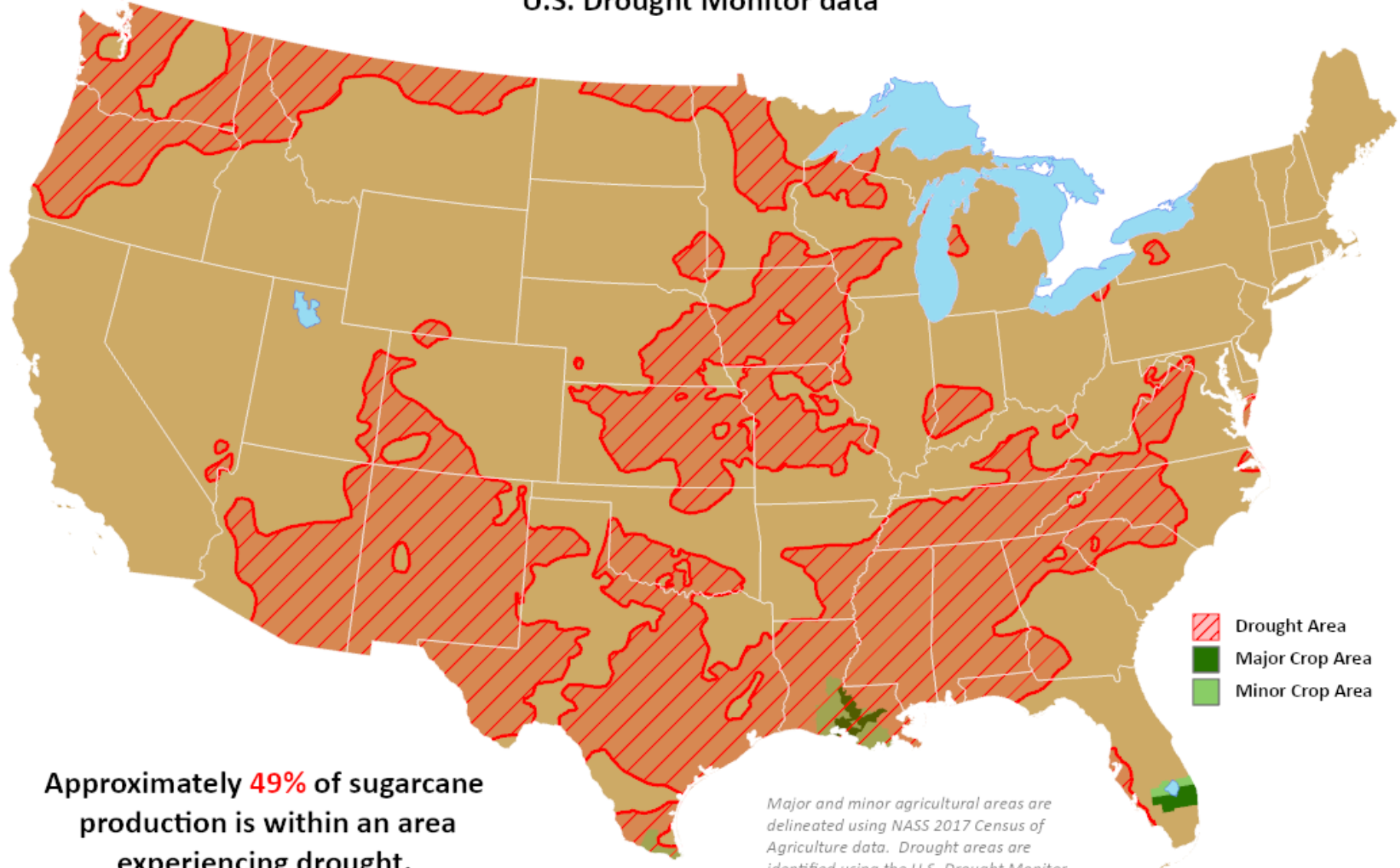

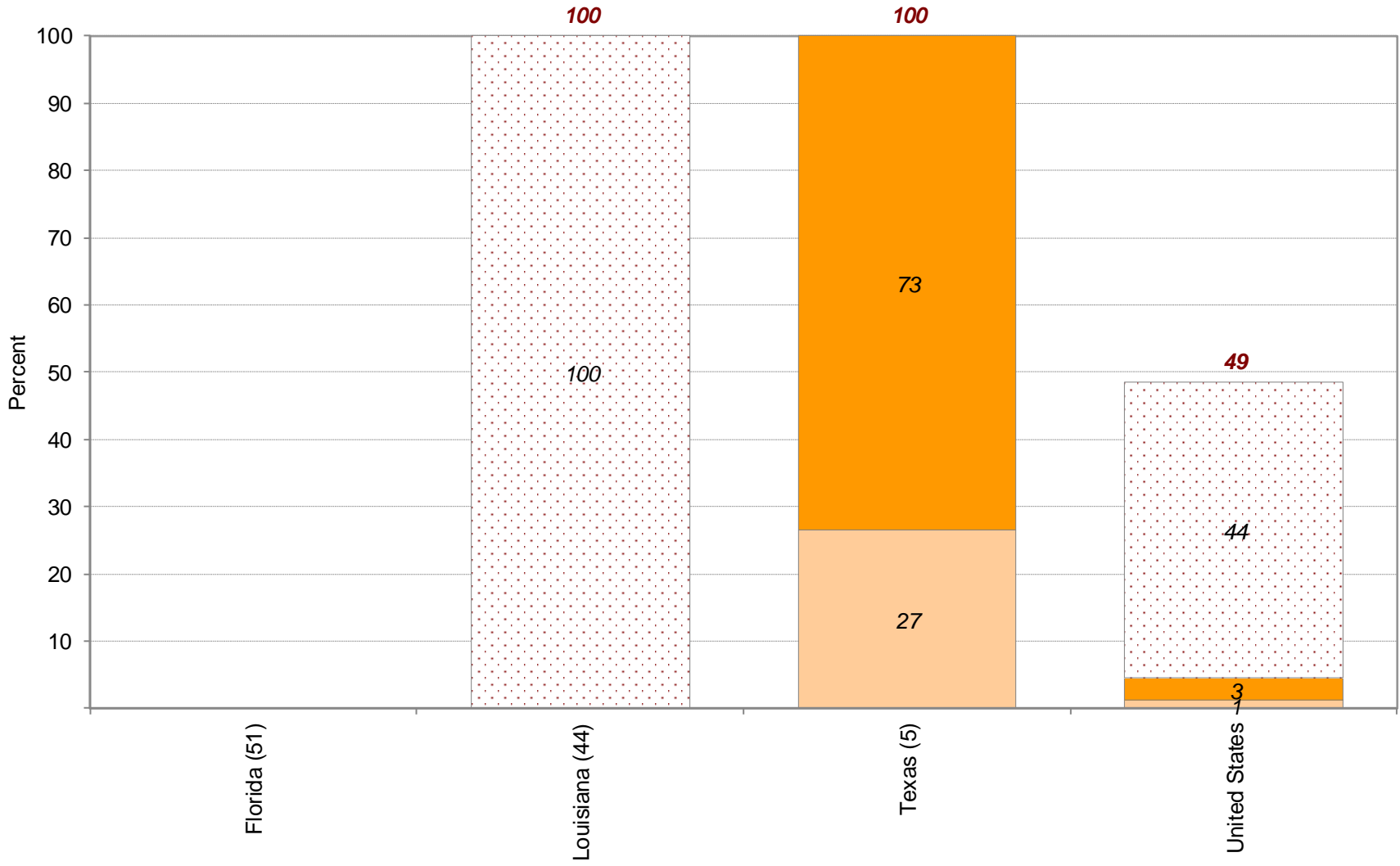

Percent of Sugarcane Located in Drought

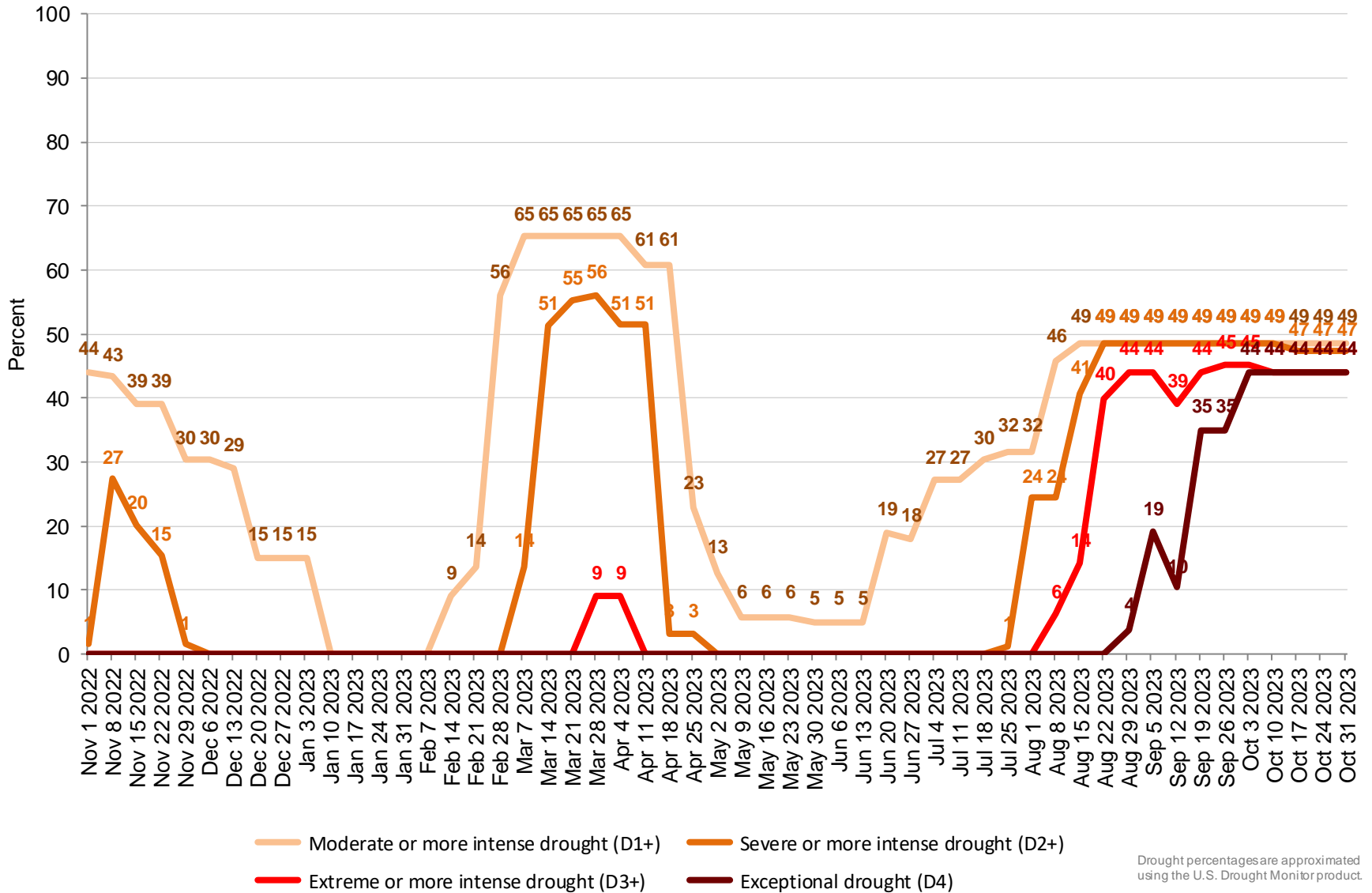
